To work 5200 or more hours of high visibility overtime traffic enforcement with an emphasis on speed to reduce the incidence of crashes in Oklahoma County.

To provide 200 or more community education and awareness opportunities across the state of Oklahoma in FFY2026, contributing to statewide traffic safety goals.

To conduct 4 Teen Driver Education courses during FFY26.

Problem Identification:

U.S. Census quick facts July 1, 2023, estimate shows 808,863 people reside in Oklahoma County representing approximately 20% of the State's population. In 2021 (most recent "CRASH FACTS" published data) it's estimated there were 8,435,244,631 miles traveled through Oklahoma County.

In 2021 there were 103 Fatal Crashes rate of 1.22 at a rate of 100 million vehicle miles traveled (MVMT) and 5815 Injury Crashes at a rate of 68.94 MVMT and a total of 21,403 total crashes in Oklahoma County and the crash rate was 253.73 per 100 million vehicle miles traveled (MVMT). There were 66,074 crashes in the state of Oklahoma. Almost a third of all crashes were in Oklahoma County. In the state of Oklahoma there were 66,074 crashes with 621 alcohol related crashes. In the state of Oklahoma there were 2869 alcohol related crashes.

According to OHSO 2021 crash data, Oklahoma County ranks in the middle third of all Oklahoma counties for number of KA crashes, number of fatal crashes, number of fatalities, alcohol-related, drug-related, unsafe speed, distracted driving, and motorcyclist with KA injuries. The county ranks high in unhelmeted fatalities. There is a downward trend in all program areas, but one unrestrained fatalities are trending upward.

Project Description:

The Oklahoma County Sheriff's Office (OCSO) will conduct overtime high visibility enforcement in support of state and national goals to reduce the incidence of KA crashes in their community. To identify those times and locations where KA crashes most often occur, the Project Director shall utilize state and local data and reference sources available. General traffic enforcement will address a greater variety of traffic violations, dependent upon local problem identification. This project will emphasize speed enforcement, in response to local data-driven needs. Public information and education (PI&E) supporting enforcement activities will be conducted monthly as part of the HVE effort to inform and educate the public on the importance of traffic safety as well as the agency's ongoing effort to deter dangerous driving behaviors.

Two (2) full-time deputies are funded as Traffic Safety Educators charged with conducting traffic safety programs statewide, utilizing the Rollover Simulator, Mule/Gator vehicle and Distracted/Impaired Driver Simulator to provide outreach statewide. These deputies will partner with schools, non-profits, and other agencies in order to expand opportunities to elevate traffic safety programs throughout the state of Oklahoma. The full time Traffic Safety Educators will attend outreach events including but not limited to road safety nights open to the public, local fairs, or any other open public safety oriented events. The Traffic Safety Educators will also put on events of their own including but not limited to going to local schools and speaking with teens and kids.

Oklahoma County SO will create a teen driver's education course. The course will be an 8-hour class where OCSO brings teen drivers with their own vehicles and pair them with a CLEET LEDT instructor for the day. Instruction will include behind-the-wheel driving and in-class instruction over different aspects of vehicle safety. Topics may include but are not limited to fatigued driving, impaired driving, and distracted driving. OCSO will host four (4) teen driver's education courses in FFY26, planning for one LEDT instructer per 10 students. Funding is provided for OCSO deputies to complete teen driver's education course in an overtime capacity. Overtime hours may include driving course set-up and breakdown for classes. Overtime funding also includes time for a bilingual deputy to assist with translation during delivery of teen driver courses and TSE events.

The Oklahoma County Sheriff's Office will participate in all NHTSA mobilizations in accordance with the terms of the grant agreement, and employ the following evidence-based strategies in conducting grant-related activities:

GLOSSARY OF DEFINITIONS

The state and each subrecipient will comply with the Buy America requirement (23 U.S.C. 313) when purchasing items using Federal funds.
