Cost Allocation Plan and Indirect Cost Rate Proposal Methodology:

Justice Benefits, Inc. compiles the Cost Allocation Plan and Indirect Cost Rate Proposal using the Simplified Method using an allocation base of salaries and wages. The following is an excerpt from 2 CFR 200, which explains the method.

Simplified method

Where a grantee agency's major functions benefit from its indirect costs to approximately the same degree, the allocation of indirect costs may be accomplished by (1) classifying the grantee agency's total costs for the base period as either direct or indirect, and (2) dividing the total allowable [as per 2 CFR 200 guidelines] indirect costs (net of applicable credits) by an equitable distribution base. The result of this process is an indirect cost rate that is used to distribute indirect costs to individual Federal awards. The rate should be expressed as the percentage which the total amount of allowable indirect costs bears to the base selected.

- b. Both the direct costs and the indirect costs shall exclude capital expenditures and unallowable costs.
- c. The distribution base may be (1) total direct costs (excluding capital expenditures and other distorting items, such as pass-through funds, major subcontracts, etc.), (2) direct salaries and wages, or (3) another base which results in an equitable distribution.

We feel that in the case of this county, the major functions of the county benefit from the central services costs in direct proportion to the personnel involved. Therefore, we have used direct salaries and benefits as our distribution base, as is suggested in 2 CFR 200. Furthermore, all Central Service allowable and unallowable costs have also been determined using 2 CFR 200, and are thus indicated in the Cost Allocation Plan.



Oklahoma County Central Service Department Descriptions

General Government

General Government Department is used to record county - wide charges that are not easily allocated and is operated by the Board of County Commissioners.

County Commissioners

The Board of County Commissioners is the chief administrative body for the County. County Commissioners are also responsible for general supervision over all fiscal affairs of the County.

The Commissioners must act as a Board when entering into contracts or other agreements affecting the County's welfare. Thus, actions taken by the board are voted on and approved by a majority of the Commissioners. The Board of County Commissioners, created by the State Constitution, is composed of three Commissioners elected by the people. The County is divided into three districts, as equal in population as possible and numbered 1, 2, and 3 respectively. One Commissioner is elected from each district. District boundaries are set once every 10 years following the federal census.

As the County's chief administrative body, the three County Commissioners must make major financial decisions and transactions. The Board has the official duty to ensure the fiscal responsibility of the other County Officers who handle County funds. The review and approval procedures empowered to the Board of County Commissioners are a means to provide the public with a fiscally efficient system of County government.

Duties of the County Commissioners:

- Supervise and manage all real estate owned by the County. The Board maintains the
 Courthouse, County Office Building, Investors Capital Building, County Jail, Human
 Services Center, Juvenile Center, Extension Center, a parking garage, and three highway
 maintenance offices.
- Advertise for bids on major County purchases and award all contracts.
- Approve all claims covering materials, supplies, or services purchased by all County offices and paid for by County funds.
- Call all County bond elections.
- Designate, construct, maintain, and repair all County highways and bridges.
- Through the Department of Training and General Assistance, provide pharmacy services and prescription medicines, emergency food vouchers, indigent burials, ambulance service, medical services, temporary housing and convalescent care, and job training for the indigent, destitute, and unemployable County residents. It also helps coordinate the federal Food Stamp program.

- Pass on all zoning applications and regulations of the County Planning Commission. (One member of the Board serves on the Planning Commission.)
- Conduct proceedings, set date of election, canvass returns, and issue Order of Incorporation of all towns and/or cities in the County.
- Audit the accounts of all County offices.
- Publish in a County newspaper a complete report of the official proceedings of all meetings of the Board.
- Appoint one member of the County Excise Board and Board of Equalization.

Treasurer

The County Treasurer is an elected constitutional officer with a four-year term whose primary function is to collect taxes certified by the County Assessor from the assessment valuations placed on real estate, personal property, and public utilities in the County.

After collection, the Treasurer disburses the moneys to the county, cities, towns and schools according to budgets approved by the County Budget Board. The County Treasurer is the official custodian of all funds for the County and Treasurer for schools and vo-tech institutions that do not have their own treasurer.

All warrants and vouchers for all County departments are registered and maintained through the Treasurer's office.

The Treasurer's office also manages of County-owned property acquired at annual sales of real estate for delinquent taxes. The Treasurer also may sell these pieces of property, upon approval of the Board of County Commissioners

All revenues received by County Government from ad valorem taxes and other sources are deposited with the County Treasurer. The County Treasurer collects ad valorem taxes for the county and its political subdivisions. The County Treasurer is authorized to issue delinquent personal property tax warrants and to impose tax liens on real property for delinquent taxes.

County Clerk

The Oklahoma State Statutes set out the duties and the responsibilities of the County Clerk.

County Audit

County Audit is used to record expenditures for various auditing services performed for the county.

Purchasing

The County Purchasing Department is responsible for analyzing all bids taken by the County for supplies, materials, and equipment. The Department strives to ensure that all purchases made by the County are the best buy for the taxpayers' dollars.

Centralized BOCC HR/Health and Safety

The Office of Environmental Health & Safety, established by the Board of County Commissioners, have the following goals and objectives.

- 1. To protect the health & safety of County employees.
- 2. To comply with regulatory agencies.
- 3. To protect the County assets against any significant losses.

These objectives are achieved through evaluation, recognition, and control of physical, chemical, biological, explosive, and other hazards.

The department administers the County's workers' compensation program and coordinates payments of claims, and also serves as the County's American's with Disabilities Act Coordinator.

Employee Benefits Department

The employee benefits department provides the administration of all active employee and retiree benefit programs. This department handles the administration of the Oklahoma County health benefits plan, prescription plan, dental plan, vision plan, wellness initiatives, annual health risk assessment testing, COBRA administration, retiree benefits, retirement process, maintain all benefit deductions, retiree billing and premium collections, retirement administration, new employee benefits administration, annual enrollment meetings, reporting to various boards, health plan reporting, actuarial reporting, voluntary benefit offerings, and benefit contracting, negotiations and renewals.

Information and Technology

The Management Information Services Department (M.I.S.) is the County's central technology provider. This department provides the computer and business information system support required by County departments. These services include network services, system support, application development and maintenance, and PC support.

Facilities Management - Courthouse/Office Buildings

Facilities Management keeps County Buildings in proper and safe working condition and ensures all county facilities are up-to-date in appearance, efficiency, and functionality. This department maintains the heating and air conditioning, lighting, plumbing, electrical, and lawn sprinkler

systems; paints offices, deals with furniture needs, repairs doors, installs and repairs locks, unlocks locks that do not have keys, supervises all janitorial services by internal and external providers, and, in general, performs all required maintenance within the capabilities of the Department.

Planning Commission

The planning commission provides professional planning support to the County Commissioners, Planning Commission and the general public for the development and implementation of State statutes and county policies and other land use plans.

County Clerk's Records Management and Preservation

The County Clerk's Records Management and Preservation account is used to record all expenses for record management and archiving services for the entire county.

Planning Commission Fee Fund

The planning commission fee fund is used to account for the fees associated with implementing development for the county.

Employee Benefits

Employee Benefits is used to record the cost of the employee benefit plans and employee insurance plans that have been adopted by the Board of County Commissioners. The county is self-insured for medical and dental claims.

Workers Compensation Insurance

Workers Compensation Insurance is used to record the cost of Workers compensation administration and claims. The county is self-insured for worker's compensation.

Self-Insurance

Self-Insurance is used to record the cost of total claims against the county as approved by the Board of County Commissioners.
