

**PROCLAMATION  
AND  
NOTICE OF SPECIAL ELECTION**

Under and by virtue of Section 19, Article X, of the Constitution of the State of Oklahoma; Section 1370 of Title 68 of the Oklahoma Statutes; Section 381 *et seq.* of Title 19 of the Oklahoma Statutes; and the Oklahoma County Sales Tax Resolution of 2026 of the Board of County Commissioners of Oklahoma County, Oklahoma, authorizing the calling of an election for the purpose hereinafter set forth, approved by the Oklahoma County Board of County Commissioners on the 21<sup>st</sup> day of January, 2026, I, the undersigned Chairman of said Board of County Commissioners of said Oklahoma County, Oklahoma hereby call a special election to be held in said Oklahoma County, Oklahoma on the 7<sup>th</sup> day of April, 2026, for the purpose of submitting to the qualified electors thereof the following Proposition:

**PROPOSITION**

Shall Oklahoma County, Oklahoma, be authorized to levy and assess a new five-eighths of one percent (0.625%) sales tax (tax increase in addition to all other state and local sales tax) commencing on July 1, 2026, and said tax shall be unlimited in duration, with said tax to be levied upon the gross proceeds or gross receipts derived from all sales taxable under the Oklahoma Sales Tax Code, providing that the purpose of the sales tax shall be to fund public safety operations and improvements within the County, including, but not limited to, operation, maintenance, construction, renovation, equipping, staffing and improvement of adult detention, juvenile detention, diversion, behavioral health, courtroom, sheriff, emergency management, emergency medical services, and public infrastructure located within Oklahoma County, Oklahoma, and/or the payment of debt service and related financing costs on obligations issued for said purpose, all as more specifically set out in the Resolution as adopted and approved by the Board of County Commissioners of Oklahoma County, Oklahoma?

- YES - FOR THE ABOVE PROPOSITION
- NO - AGAINST THE ABOVE PROPOSITION

That only the registered, qualified voters of Oklahoma County, Oklahoma, may vote upon the proposition as above set forth.

Said Election shall be conducted in all of the regular voting places established by the Oklahoma County, Oklahoma Election Board and conducted by the regular precinct officers appointed by said County Election Board for the purposes of conducting the election and certifying the results as required by law.

The polls shall be opened at 7:00 A.M. and remain open continuously until and be closed at 7:00 P.M.
