





Oklahoma Natural Gas Company, a division of ONE Gas, Inc. ("Oklahoma Natural" or "Company"), has filed an Application with the Oklahoma Corporation Commission ("Commission") requesting review and approval of its calculations under the Performance Based Rate Change Plan ("PBRC").

Public Comment on these matters will be heard by the Commission's Administrative Law Judge at 10:00 a.m. on June 12, 2025, in the Concourse Theater, Suite C50, located in the underground tunnel between the Will Rogers Memorial Office Building and the Sequoyah Memorial Office Building. Entrance to the Concourse Theater is through the Will Rogers Memorial Office Building, 2401 N. Lincoln Boulevard, Oklahoma City, Oklahoma. All interested persons may appear and provide comment at that time. In addition, members of the public may also provide written comments by mail to the Oklahoma Corporation Commission, P.O. Box 52000, Oklahoma City, OK 73152 or by email to PUDenergy@occ.ok.gov with "Attention: Public Comment PUD2025-000011" in the subject line.

Following Public Comment, the Hearing on the Merits ("Hearing") will be heard before an Administrative Law Judge commencing on June 12, 2025, at 10:00 a.m., and continuing each business day thereafter until the Hearing concludes. After the Hearing, the Commission will issue such orders and grant such relief as it deems proper, necessary, fair, just, and reasonable, whether or not specifically required in the Application.

Oklahoma Natural is seeking an increase of approximately \$41,504,750 in base rates. The requested increase is necessary to recover increased business costs and natural gas infrastructure investments. Oklahoma Natural invested approximately \$272 million in capital investments since its last base rate increase, a PBRC review with a test year ending December 31, 2023. In addition, the Company is requesting approval of an accounting change in compliance with IRS guidance, the energy efficiency true-up and utility incentive adjustments for program year 2024, and modifications to its tariffs. The proposed increase would raise an average residential customer's monthly service charge by approximately \$3.24 and \$1.03 for a residential low-income customer.

Additionally, as part of its compliance with the Tax Cuts and Jobs Act of 2017, Oklahoma Natural will continue to return to customers excess deferred income taxes ("EDIT"), both protected and unprotected. The one-time annual EDIT credit for 2025 is \$13,243,908, subject to true-up. This EDIT credit equates to \$13.39 for an average residential customer and \$3.96 for a residential low-income customer. The one-time annual EDIT for 2025 will be paid in February 2026. This credit is separate and in addition to the requested increase described above.

In consideration of the requested base rate increase, the proposed adjustment to reflect the energy efficiency true-up and utility incentive calculations for program year 2024, and the one-time EDIT credit for 2025, the estimated total impact to the monthly bill for an average residential customer is \$2.12 and \$0.70 for a residential low-income customer.





CONSULTING SERVICES AGREEMENT

This Agreement entered into by and between the Oklahoma County Criminal Justice Authority, a public trust, hereinafter called "OCCJA," and Robert Cox, Winston Services, hereinafter called "Contractor," constitutes the entire Agreement between the OCCJA and Contractor.

ARTICLE I OUALIFICATIONS

Contractor is a private entity and not an agent of OCCJA or Oklahoma County or any other division or department of the County.

Confractor is an expert in tort and workers compensation claim investigations and fully licensed.

Contractor agrees to investigate on behalf of and report to the District Attorney's Office, which serves as counsel for OCCJA, in *Billy Joe Altstatt, Guardian of Johnny Lee Altstatt v OCCJA*, et al., United States District Court, Western District of Oklahoma, CIV-22-811-D as provided for in this Agreement. The scope of services will be set by the District Attorney's Office and adjusted as needs arise or change.

ARTICLE II AGREEMENT PERIOD

This Agreement shall become effective (1st) day of March 2024 and shall terminate at the close of the (30th) day of June, 2024.

ARTICLE III NO PERSONAL BENEFIT TO OFFICIALS AND EMPLOYEES

No official or employee of OCCJA or any other employee of the Oklahoma County Government shall receive any share or part of the fees paid under the Agreement, or any benefit that may arise therefrom, and no employee of OCCJA, the County or officer, official or employee of the County shall serve as an employee of the Contractor's organization.

ARTICLE IV ALLOWABLE COST AND PAYMENT

Contractor will provide investigation services and consultation to counsel for OCCJA reporting only to the District Attorney's Office of Oklahoma County. In return for services provided, OCCJA agrees to pay Contractor \$75 per hour. Travel expenses for travel outside of Oklahoma County or Oklahoma City must be approved in advance and must be billed at actual cost. Mileage cannot exceed the IRS allowable rate. Total reimbursement pursuant to this contract cannot exceed Five Thousand Dollars (\$5,000.00).

Payment for services rendered will be made only upon receipt of documented billing claims. These billing claims shall be submitted, as required, but no more often than monthly and no later than July 30, 2024 in the format and in accordance with procedures prescribed by the OCCJA. All billing under this Agreement shall be submitted solely to the District

Attorney's office for approval and will be paid by the OCCJA. The District Attorney's Office has no obligation to pay.

In the event billing claims are subsequently disallowed by OCCJA pursuant to the Agreement, the Contractor shall repay OCCJA on demand, the amount of any such disallowed claim(s) or at the discretion of OCCJA may deduct such amounts from subsequent payments to be made to the Contractor hereunder without prejudice however to OCCJA's right thereafter to establish the appropriateness of any billing under this Agreement.

ARTICLE V SPECIAL PROVISIONS

There are no special provisions.

ARTICLE VII EQUAL OPPORTUNITY AND DISCRIMINATION

OCCJA and the Contractor agree they are equal opportunity employers and in compliance with Federal regulations, at Title 45, Code of Federal Regulations, Part Eighty (80) (which implement P.L. 88-352 Civil Rights Act of 1964) and execute orders there under and the Rehabilitation Act of 1973, as amended, including but not limited to, giving equal opportunity both to those seeking employment and those seeking services without regard to race, color, religion, sex, national origin or handicap.

ARTICLE VIII LIABILITY

Contractor shall perform his work under this Agreement as an independent contractor and agrees that OCCJA is to be free from all liabilities and damages resulting from his performance hereunder. It is further agreed that Contractor will indemnify and hold harmless OCCJA against all claims and causes of action of any kind and character, which may arise as a result of Contractor's performance under this contract.

Contractor agrees not to hold OCCJA liable for any personal loss of property or personal injury or death, which may result from his/her rendering of any services by Contractor pursuant to this Agreement.

ARTICLE IX COMPLIANCE WITH LAW

Contractor agrees to comply with all applicable State and Federal Laws, statutes, regulations, rulings or enactments of any governmental authorities that are applicable to this Agreement. Observance of and compliance shall be the responsibility of Contractor without reliance on, or superintendent of, or direction by OCCJA.

Contractor understands they are responsible for payment of wages and benefits required by federal law (i.e., FICA) to any persons employed by Contractor to fulfill obligations of this contract.

ARTICLE XII OWNERSHIP INFORMATION

Contractor affirms that no person who has ownership or controls interest in, or is an agent or managing employee, has been convicted of a criminal offense involving moral turpitude.

ARTICLE XIII CANCELLATION TERMINATION

Either party may terminate this Agreement at any time for any reason. The District Attorney's office may terminate the Agreement at any time on behalf of OCCJA.

ARTICLE XIV **MODIFICATION**

Contractor is not authorized to change any provision of this Agreement. All changes shall be consummated by formal written amendment agreed and executed by both OCCJA and Contractor.

This Agreement is made in the State of Oklahoma and shall be governed by the laws of the State of Oklahoma, and Article 10 Section 26 of the Oklahoma Constitution.

For the faithful performance of the terms of this Agreement the parties hereto in their capacities as stated affix their signatures.
