

**PROCLAMATION
AND
NOTICE OF SPECIAL ELECTION**

Under and by virtue of Section 19, Article X, of the Constitution of the State of Oklahoma; Section 1370 of Title 68 of the Oklahoma Statutes; Section 381 *et seq.* of Title 19 of the Oklahoma Statutes; and the Oklahoma County Sales Tax Resolution of 2026 of the Board of County Commissioners of Oklahoma County, Oklahoma, authorizing the calling of an election for the purpose hereinafter set forth, approved by the Oklahoma County Board of County Commissioners on the 12th day of August, 2026, I, the undersigned Chairman of said Board of County Commissioners of said Oklahoma County, Oklahoma hereby call a special election to be held in said Oklahoma County, Oklahoma on the 3rd day of November, 2026, for the purpose of submitting to the qualified electors thereof the following Proposition:

PROPOSITION FOR A SALES TAX INCREASE IN OKLAHOMA COUNTY

Shall Oklahoma County be authorized to levy and assess a new four-tenths of one percent (0.40%) sales tax? This sales tax will apply to all sales taxable under the sales tax laws of the State. This sales tax will be in addition to existing state and local sales taxes. This sales tax will be used to operate, maintain, construct, renovate, finance, equip, and pay staff of county detention, diversion, and mental health facilities and programs. This sales tax will be for a period of twenty-five (25) years. This sales tax will start on April 1, 2027, and will end on March 31, 2052. A “yes” vote will increase sales taxes in Oklahoma County by 0.40%. A "yes" vote will not decrease taxes in Oklahoma County. This sales tax will only be used for the purposes described by this Proposition.

That only the registered, qualified voters of Oklahoma County, Oklahoma, may vote upon the proposition as above set forth.

Said Election shall be conducted in all of the regular voting places established by the Oklahoma County, Oklahoma Election Board and conducted by the regular precinct officers appointed by said County Election Board for the purposes of conducting the election and certifying the results as required by law.

The polls shall be opened at 7:00 A.M. and remain open continuously until and be closed at 7:00 P.M.
