

**OKLAHOMA COUNTY RENEWAL AGREEMENT
FISCAL YEAR 2026-2027**

This Renewal Agreement is entered into by and between the Board of County Commissioners of Oklahoma County, with a principal place of business located at 320 Robert S. Kerr, Oklahoma City, Oklahoma 73102 and Axon Enterprise, Inc., with a principal place of business located at 17800 NW 85th Street, Scottsdale, AZ 85255.

WITNESSETH

WHEREAS, the Board of County Commissioners and Axon Enterprises, Inc. entered into an Agreement dated 7/1/2024 for purchase of TASER10s and initial year of service, (hereinafter “Original Agreement.”) Under the terms of this Original Agreement, the County is given 4 options to renew service, each for a period of one year.

WHEREAS, the parties desire to exercise the right to renew the Original Agreement.

THEREFORE, in consideration of the foregoing and of the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below.

1. **TERM**: Pursuant to memo attached to the Original Agreement, the parties agree to extend the term of the Original Agreement for one year from July 1, 2026, through June 30, 2027.

2. PRICE ADJUSTMENT: Pursuant to memo attached to the Original Agreement, the parties agree that the compensation to be paid to Axon shall be \$60,693.98.

3. EFFECT OF RENEWAL: Except as specifically set forth herein, all other terms and conditions of the Original Agreement shall remain unaffected by this renewal agreement and continue in full force and effect.
