The amendment includes the remaining funds from Fiscal Year 2024-2025, Two Hundred Twenty-Six Thousand One Hundred Fifty-Seven Dollars and Eighty-Four Cents (\$226,157.84) and an amount not to exceed Two Million Two Hundred Thirty-Four Thousand Five Hundred Sixty-Three Dollars and Fifty Cents (\$2,234,563.50) received in Fiscal Year 2025-2026. The Amendment and Extension

Agreement will extend the terms of the original Agreement dated April 10, 2024, and any subsequent amendments thereto for a period of 12 months commencing on July 1, 2025, and ending on June 30, 2026. 
