OKLAHOMA COUNTY JUVENILE BUREAU MASTER AGREEMENT FOR COMPREHENSIVE MENTAL HEALTH SERVICES AT THE OKLAHOMA COUNTY JUVENILE DETENTION FACILITY AMENDMENT

This Amendment shall serve as a revision to the Contract for Comprehensive Mental Health Services (the "Main Agreement") between the **Oklahoma County Juvenile Bureau** ("Agency") and **Turn Key Health Clinics, LLC, dba TK Health** ("Contractor") which initiated on May 15, 2023 at the Oklahoma County Juvenile Detention Center.

In consideration to the mutual covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, it is agreed upon as follows:

- 1. The terms and conditions of this Amendment, as set forth below, shall be effective as of December 15, 2025, through June 30, 2026.
- 2. Section 1.15 ("Healthcare Personnel Services Provided"), shall be revised as follows:
 - a. Up to ten (10) hours a week of individual counseling services provided by a licensed Mental Health Professional (LPC, LCSW, LMHC, LMHP, LMFT, LADC, or comparable license) via either on-site clinic or via telehealth;
 - b. Up to two (2) hours a week of psychiatric evaluation and treatment by a licensed Psychiatrist or Psychiatric Nurse Practitioner via telehealth. Services will include prescribing and assessing detention residents' medication.
- 3. Section 2.1 of the Main Agreement shall be amended as follows:

The reimbursement for the Contract from shall be paid by the Agency to the Contractor on a monthly basis in the amount of Nine Thousand, Eight Hundred Fifty-Eight Dollars and Fifty-Eight Cents (\$9,858.58), pro-rated for any partial months and subject to any reconciliation, as applicable. The first payment for the month of December 2025 is to be paid to the Contractor by the 1" day of January 2026 for services administered for the month of December. All subsequent payments shall be paid in the full amount by the Agency to the Contractor before or on the 1" day of the month for services rendered the previous month.

4. In all other respects, the terms and conditions of the Main Agreement and Amendments thereto shall continue unchanged and remain in full force and effect.
