

## TRADS PRICING ADDENDUM

This Pricing Addendum ("Addendum") is entered into as of the date signed by the Subscriber below between TransUnion Risk and Alternative Data Solutions, Inc. ("TRADS") and **Oklahoma County** ("Subscriber"), and establishes the pricing for services provided to Subscriber by TRADS under the Agreement dated by and between TRADS and Subscriber, as amended and supplemented (the "Agreement").

- 1.a. TRADS Services-Pricing.** Subject to the terms and conditions of the Agreement, the following is the current pricing for the selected services (the "TRADS Services") and applies to the following Subscriber ID or Account Number 6711244. All other TRADS Services are subject to TRADS' then-current fees and charges, which may change from time to time. Not more than once per year of the Term, TRADS reserves the right to increase the pricing under this Addendum.

### **TLOxp Online (01072) Per Seat 1010101**

Each month during the Term, Subscriber shall pay:

**"Minimum Seats": 7 at \$143.00 per month, per seat.** In no event shall the seats be reduced below the Minimum Seats.

#### **Additional Seat(s) Above Minimum Seats.**

Additional Seats will be charged at the same monthly per seat rate specified above. If Subscriber adds to the number of seats above the Minimum Seats during a billing period, the charges and transactions will be prorated. Reductions in Additional Seats will take effect from the first day of the next billing period.

**Monthly Transactions Per Seat: Unlimited.** The per seat pricing includes the Number of Monthly Transactions Per Seat.

All Transactions are billed at the then-current fees and charges as per the online Rate Card.

### **1.b. Online Definitions.**

**"API"** means TRADS' application programming interface means of accessing the TRADS Services. *Access via API is subject to approval by TRADS for an API connection and Subscriber complying with associated requirements for API access. Not all data is available via the API access method.*

**"Transaction(s)"** mean(s) any information returned by TRADS in response to a search query (whether in the form of search results or a report).

**"Transactional Rates"** refers to the then-current fees and charges for the TRADS Services on a per-Transaction basis.

**"Excluded Items"** defined as:

Any gateway or royalty incurring product search or transaction;

Comprehensive Reports, standard Reports and searches called out on Exhibit A

- 2. Term.** The term of this Addendum shall begin on 08/01/2026 (the "Commencement Date") and shall remain in effect for the Initial Term of 36 month(s) (the "Initial Term"). Upon expiration of the Initial Term, this Addendum:

**Expires**, and Subscriber's continued usage of TRADS Services, absent this Addendum, is subject to the terms and conditions of the Agreement at TRADS' then-current fees and charges

- 3. Early Termination Fee ("ETF").** Upon termination of this Addendum by Subscriber before the end of the Term, Subscriber shall pay TRADS an ETF equal to the average total monthly fees due hereunder within a billing period multiplied by the number of months remaining in the Initial Term. TRADS is also entitled to the cost of collection for the ETF including attorneys' fees. TRADS reserves the right to terminate this Addendum for convenience at any time, but in such instance, Subscriber shall not be responsible for any ETF. ETF does not apply i) to TRADS Law Enforcement customers; or ii) if Subscriber terminates for TRADS breach.

- 4. Price Changes.** In the event TRADS' cost of rendering products or services increases as a result of federal, state or local laws or ordinances, regulatory, administrative, governmental, or judicial acts, and/or data vendor provider changes, then TRADS may implement a surcharge subject to the following: (i) any surcharge will be applicable generally to TRADS' customers; (ii) TRADS will provide written notice to Subscriber prior to implementing such surcharge; and (iii) any surcharge will be applied only to products and services pertaining to consumers in the geographic area affected by the change of law, ordinance, regulatory, administrative, governmental, or judicial act. A legislative surcharge is imposed on certain types of reports pertaining to consumers residing in the United States, and an additional surcharge is imposed on certain reports pertaining to only Colorado residents.

5. **Confidential Information.** This Addendum is TRADS' Confidential Information and may not be shared by Subscriber with any third party absent TRADS' express prior written consent.
6. **Miscellaneous.** Except as expressly revised by this Addendum, all other terms and conditions of the Agreement shall remain in full force and effect. This Addendum is approved and accepted, as of the above Commencement Date, on behalf of the parties. The parties agree that a facsimile or other electronic transmission of an unmodified image (e.g., transmission in a portable document format "pdf") of this fully executed Addendum shall constitute an original and legally binding document. In the event any one or more provisions of this Addendum is held to be invalid or unenforceable, the enforceability of any remaining provision(s) shall be unimpaired. All capitalized terms used but not defined in this Addendum will have the same meanings given to them in the Agreement.
