

**Addendum to an Existing Contract**  
**ARPA SUBRECIPIENT AGREEMENT**  
**BOARD OF OKLAHOMA COUNTY COMMISSIONERS**  
**And**  
**Hope is Alive**

THIS CONTRACT ADDENDUM is in reference to a contract agreement and addendum dated 9/27/2024 and 08/05/2025 (respectively) between the Board of Oklahoma County Commissioners, herein referred to as COUNTY, and the Hope is Alive, herein referred to as SUBRECIPIENT.

THAT WHEREAS, the COUNTY and the SUBRECIPIENT have entered into an agreement for SUBRECIPIENT for the provision of ARPA funding for projects managed by the SUBRECIPIENT.

- The ARPA funding will be used to enhance Hope is Alive’s addiction recovery services in Oklahoma County by focusing on three key areas: hiring three PRSS-certified staff members to provide specialized guidance and evidence-based interventions; offering scholarships to ensure low-income individuals can access recovery services; and covering entrance fees for transitional living programs to remove financial barriers and facilitate sustainable recovery.

A copy of the original contract is made part of this Addendum;

WHEREAS, the parties hereto desire to reduce the terms of this Amendment to writing;

NOW, THEREFORE, for and in consideration of the mutual promises to each other, as hereinafter set forth, the parties hereto do mutually agree to the contract addendum as follows:

- **KPI 3:** The organization will successfully transition 70% of Healing Center scholarship awardees to the Hope is Alive transitional housing program.
