

**OKLAHOMA COUNTY RENEWAL AGREEMENT
FISCAL YEAR 2025-2026**

This Renewal Agreement is entered into by and between the Board of County Commissioners of Oklahoma County, with a principal place of business located at 320 Robert S. Kerr, Oklahoma City, Oklahoma 73102 and the City of Oklahoma City, with a principal place of business located at 200 N. Walker Ave., Oklahoma City, OK 73102.

WITNESSETH

WHEREAS, the Board of County Commissioners and the City of Oklahoma City entered into an Agreement dated July 1, 2023 for annual radio system services (hereinafter “Original Agreement.”) Under the terms of this Original Agreement, the County is given 4 options to renew, each for a period of one year.

WHEREAS, the parties desire to exercise the right to renew the Original Agreement.

THEREFORE, in consideration of the foregoing and of the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below.

1. **TERM**: Pursuant to Section 5, the parties agree to extend the term of the Original Agreement for one year from July 1, 2026, through June 30, 2027.
2. **PRICE ADJUSTMENT**: Pursuant to Exhibit A, the parties agree that the compensation to be paid to the City of Oklahoma City shall be

\$89,700.00 for capital replacement allocation and \$17.32 per portable radio per month not to exceed \$57,156.00 and \$24.91 per mobile radio per month not to exceed \$55,300.20.

3. EFFECT OF RENEWAL: Except as specifically set forth herein, all other terms and conditions of the Original Agreement shall remain unaffected by this renewal agreement and continue in full force and effect.

IN WITNESS THEREOF, the parties have caused this Renewal Agreement to be signed by their duly authorized representatives.
