

**OKLAHOMA COUNTY RENEWAL AGREEMENT
FISCAL YEAR 2026-2027**

This Renewal Agreement is entered into by and between the Board of County Commissioners of Oklahoma County, with a principal place of business located at 320 Robert S. Kerr, Oklahoma City, Oklahoma 73102 and Saltus Technologies, with a principal place of business located 110 S Hartford, Suite 1001, Tulsa, OK 74120.

WITNESSETH

WHEREAS, the Board of County Commissioners and Saltus Technologies entered into an Agreement dated 10/16/2024 for an electronic ticketing software as a service (hereinafter "Original Agreement." Under the terms of this Original Agreement, the County is given annual options to renew, each for a period of one year.

WHEREAS, the parties desire to exercise the right to renew the Original Agreement.

THEREFORE, in consideration of the foregoing and of the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below.

1. **TERM**: Pursuant to Section 6.0, the parties agree to extend the term of the Original Agreement for one year from July 1, 2026, through June 30, 2027.

2. PRICE ADJUSTMENT: Pursuant to the attached quote, the parties agree that the compensation to be paid to Saltus Technologies shall be \$39,600.00 for 50 users.


3. ADDITIONAL SERVICES: In addition to the services provided under the terms of the Original Agreement, Saltus Technologies agrees that if usage consistently exceeds the licensed quantity, the contract will be amended to reflect an agreed upon increase.

4. EFFECT OF RENEWAL: Except as specifically set forth herein, all other terms and conditions of the Original Agreement shall remain unaffected by this renewal agreement and continue in full force and effect.
