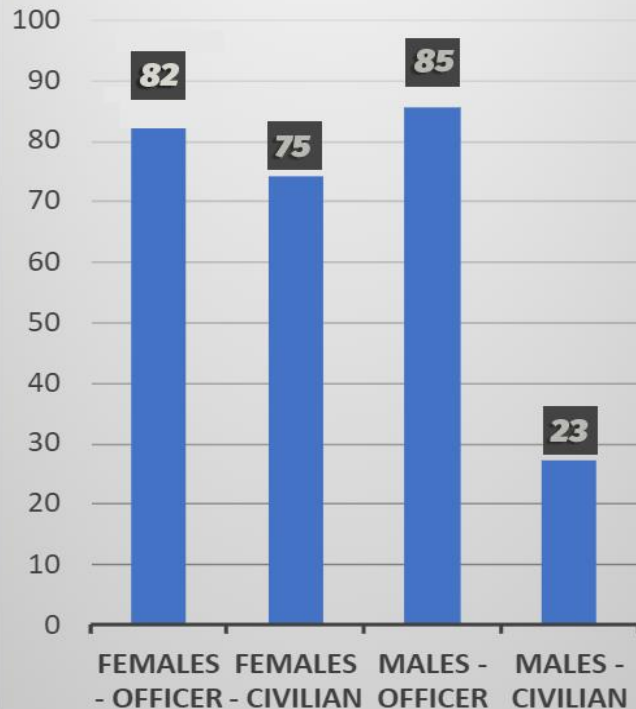

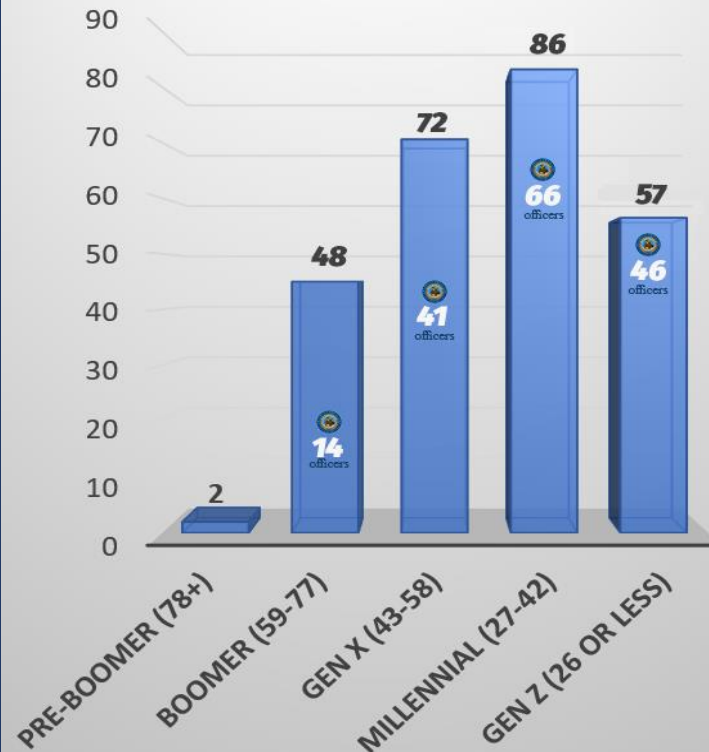

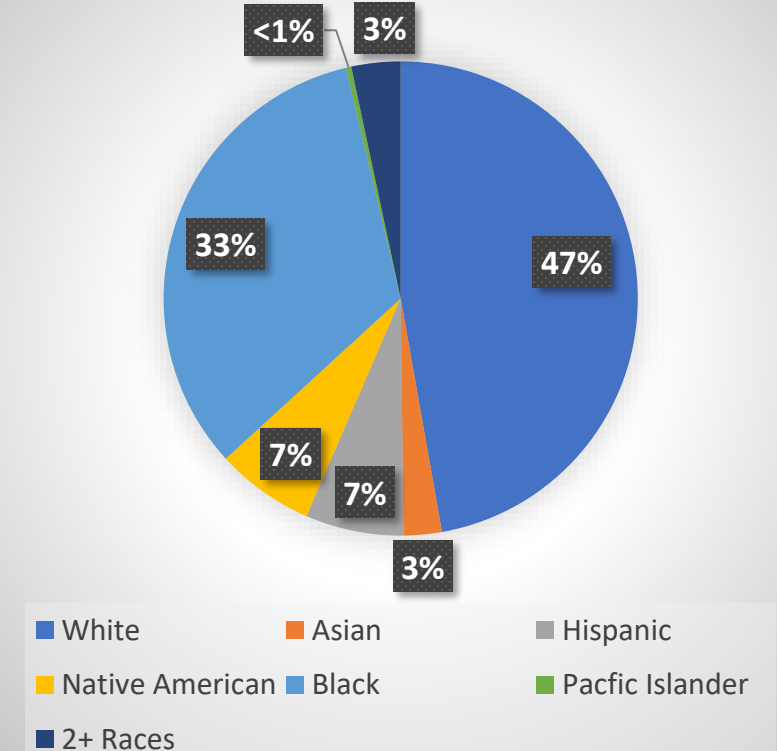
Gender & Job Classification

TRAINING UPDATES

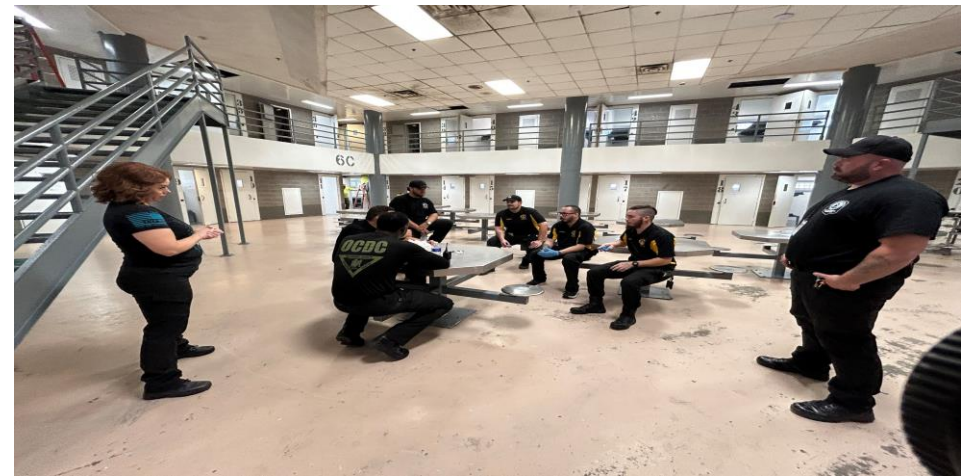
Current Academy Extended to **8 Weeks**

- Daily PT (Scissortail park)
- Discussions w/ those who have lived experience

Revamping OJT (On the Job Training) to mimic FTO (Field Training Officer) Programs

- Daily Observation Reports
- Documents skill performance and competency
- Standardized Evaluation Guidelines

New Wellness Unit

Hired Wellness Unit Director

- Licensed Counselor for staff
- Experience with Detention Staff & Residents
- Promoting mental, emotional, & physical wellbeing of staff
- Provide direct counseling services, wellness programs, critical incident debriefings, offering support to staff and, at times, residents
- KPI – Reduction in employee turnover, call-outs, FMLA, improved job satisfaction, retention, morale

Creation of Lactation Room & Wellness/Decompression Room

- Vendor-supported
- Prioritizes Officer Wellness & Mental Health
- Researched Benefits of Wellness Room in Corrections:
 - Reduced Stress Levels
 - Improved Decision-Making
 - Increased Energy & Productivity
 - Enhanced Physical Health

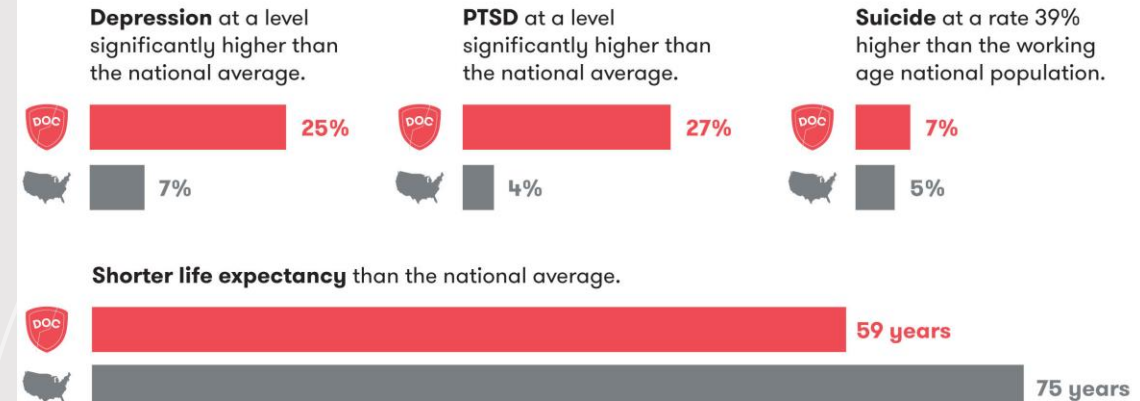
Correctional officer stress stems from two primary sources:

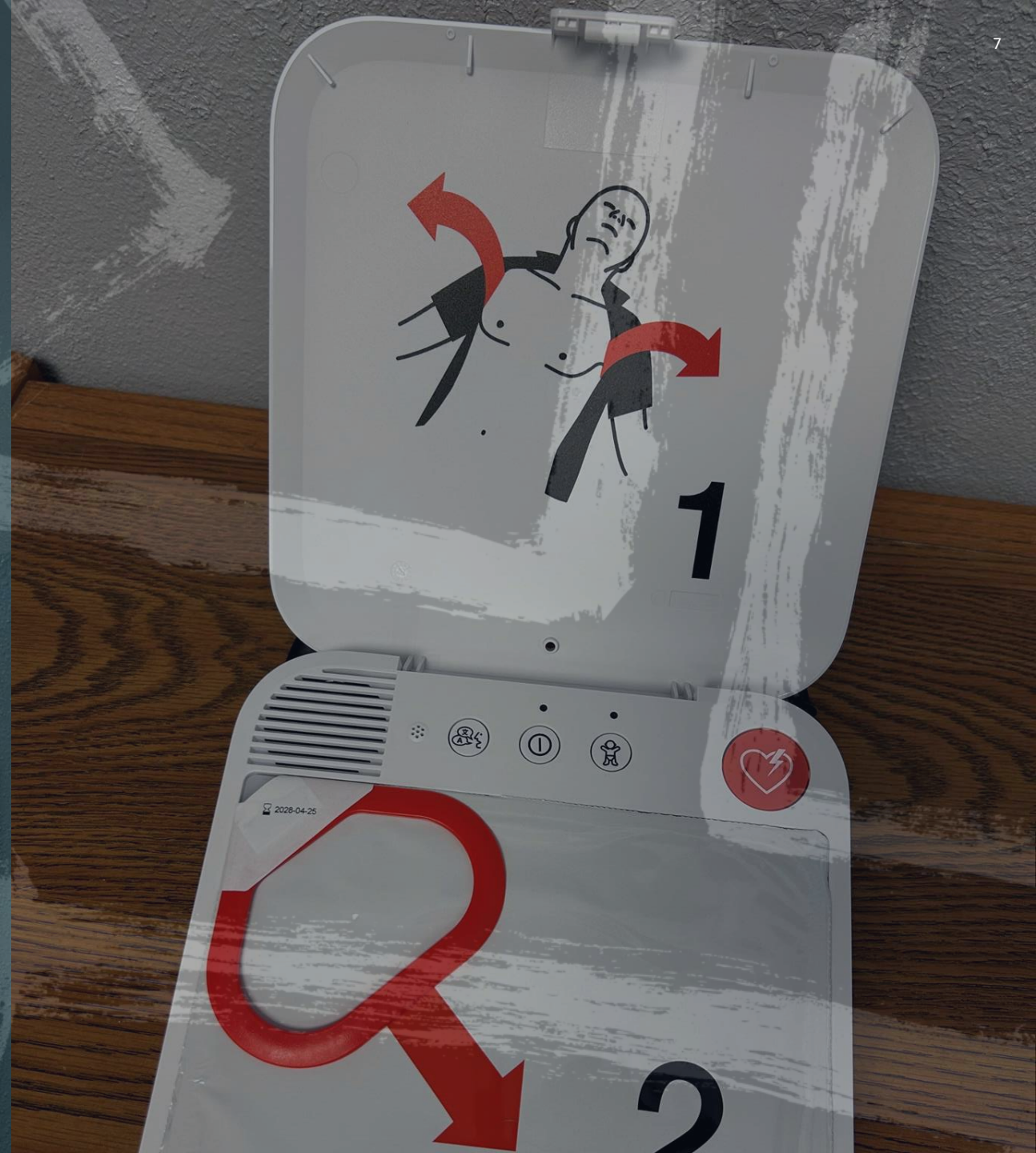

RENOVATIONS UPDATE

- **CURRENT**
 - 6th Floor – **COMPLETED**
- **COMPLETED**
 - 4th Floor – A, B, C, D Pods
 - 6th Floor – A, B, C, D Pods
 - Holding Cells – Intake

- Made repairs to all areas of housing units
- Deep cleaned all surfaces
- Sealed concrete
- Repainted with proper paint
- **GOALS**
 - Improve living conditions
 - Increase visibility (reflects light, thereby enhances quality of sight checks)
 - Improves mental health of residents
 - Seal pores in concrete previously harboring pests/eggs
 - Increased accountability for cleanliness & graffiti
 - Improves ability to detect damage to walls/windows



- Sealed shower floors to increase cleanliness and reduce slipping



RESIDENT WELFARE & PROGRAMS – CURRENT

- NEW – Lynn Institute and Arts Council – arts programs/workshop
- NEW - Gift Bag distribution – TEEM 9/14/24 – distribution to population
- NEW - Mental Health/Substance abuse intake screening data collection
 - Assist with diversion programs and alternatives to incarceration
 - Program development / placement
- Veteran's Group to meet every other Friday – 8 male resident participants
- Voting initiative for residents
- C.A.R.E. UNIT (Community Assistance, Resources, & Empowerment)
- Stand Up Initiative (DHub: 18-24 w/ Firearms/Violent Charges)
- Calm Waters Grief Support
- Alcoholics Anonymous
- Prison Fellowship Academy
- Shred the Stigma (Harm Reduction / Peer Recovery Support)
- Free Courses via Tablets (criminogenic needs – education, psych/social, family, substance abuse, employment, etc.)
- Bus Pass Grant: 720 annually / 60 per month

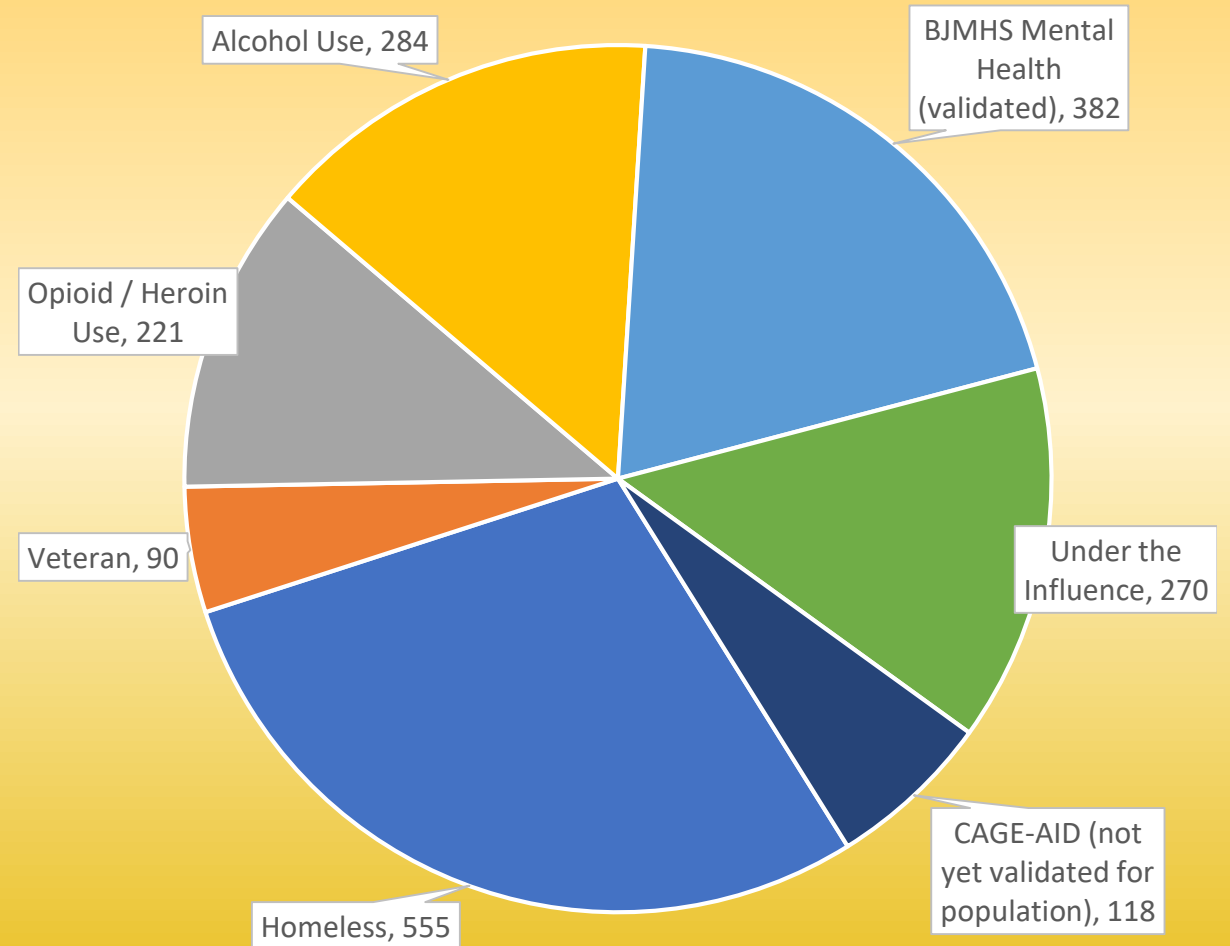




Intake Screening

- Began consistently tracking data from intake screening 8/20
- Graph shows 44 days of data 2801 intakes during period
 - 1,047 (37.37%) screened positive for at least one category
 - Data depicted will have overlap
 - Data is self-reporting at intake
- Combination of validated / unvalidated assessments & questionnaires
 - Brief Jail Mental Health Screen (validated – 2005 Policy Research Associates; Delmar)
 - CAGE-AID (unvalidated for population currently but recommended by MHAOK to assess alcohol and drug abuse/dependency)

Intake Screening

- Goals of collecting data:
 - Determine prevalence of common factors to incarceration
 - Direction of Resources
 - Program Development
 - Diversion Opportunities
 - C.A.R.E. Unit – Narcan Distribution / treatment resources at release
- 8/20 - 10/3 data
 - 44 days of data
 - 2801 intakes during data period
 - 1044 (37.37%) screened positive for at least one category
 - Data depicted will have overlap
 - Data is self-reporting at intake

6. Radio interoperability project completed



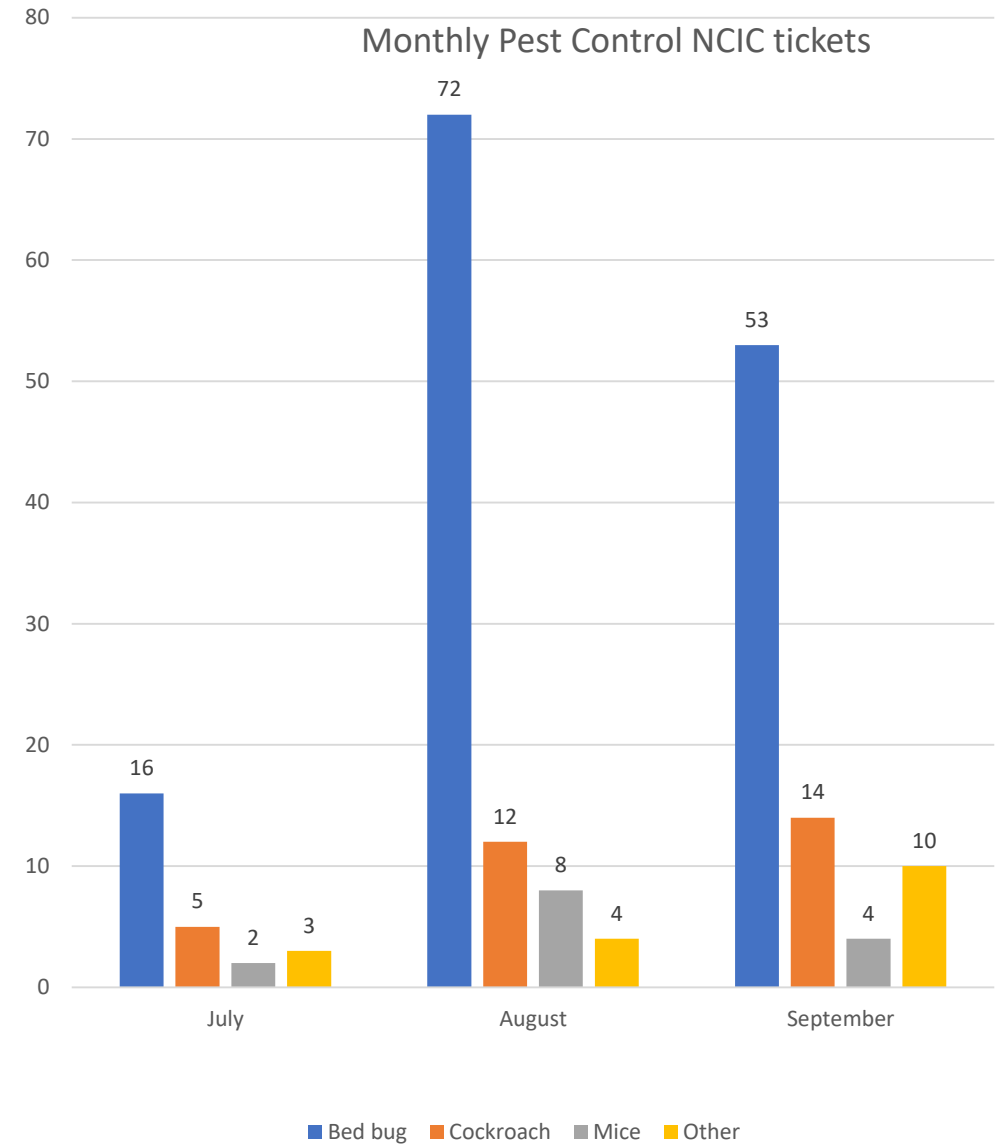

- State Certified applicator responds to issues





CID – CRIMINAL INVESTIGATION DIVISION

11 Cases opened in September

- **7 cases closed**
 - **5 inmate on inmate**
 - **2 attempted suicide**
 - **Destruction of evidence by inmate**

Ongoing

- **2 Detention Officers arrest in August – Case has expanded since initial arrests**
- **Introduction of contraband through the mail**
- **Detention officer arrest and terminated for embezzlement**

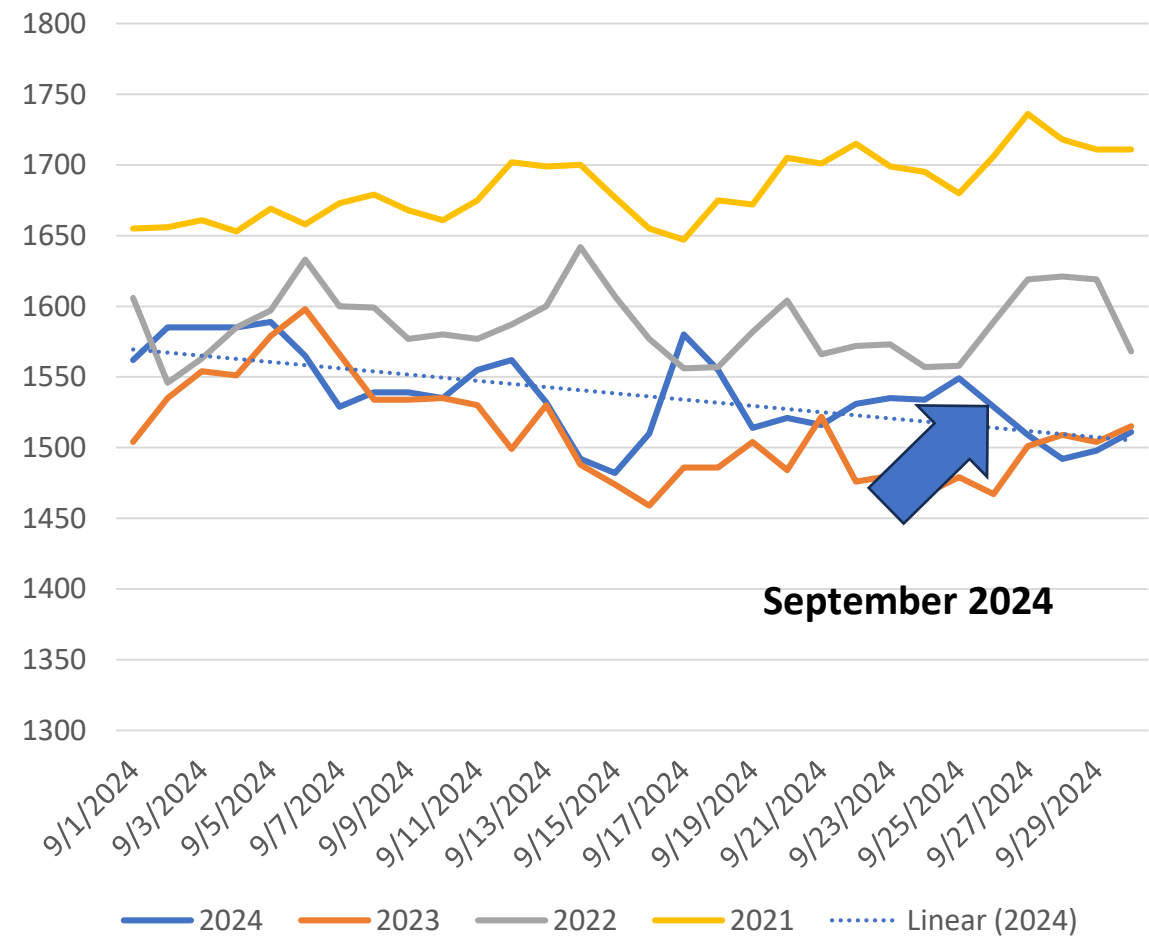

September 2021-2024

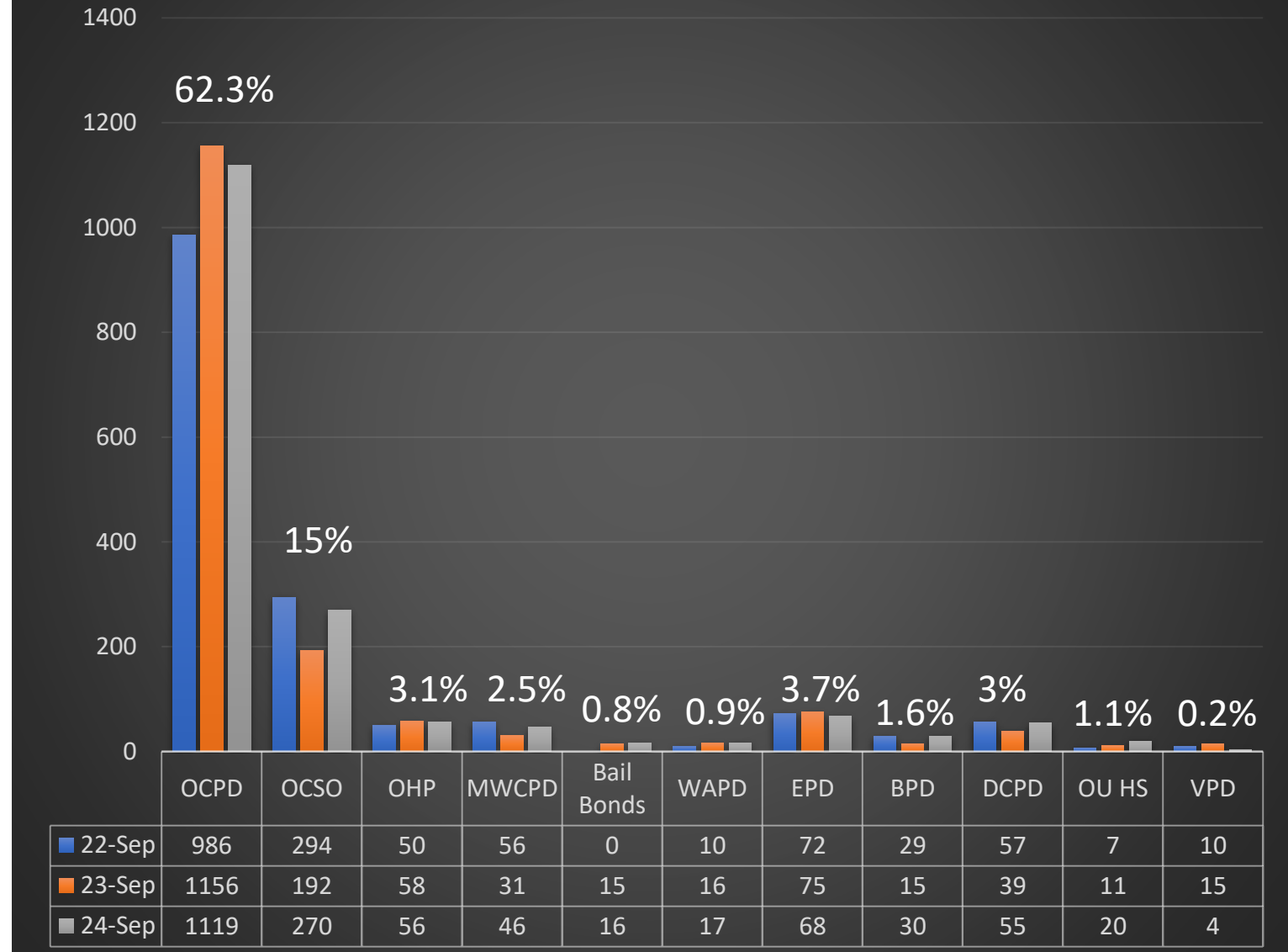




September 2024 Agency Booking Total

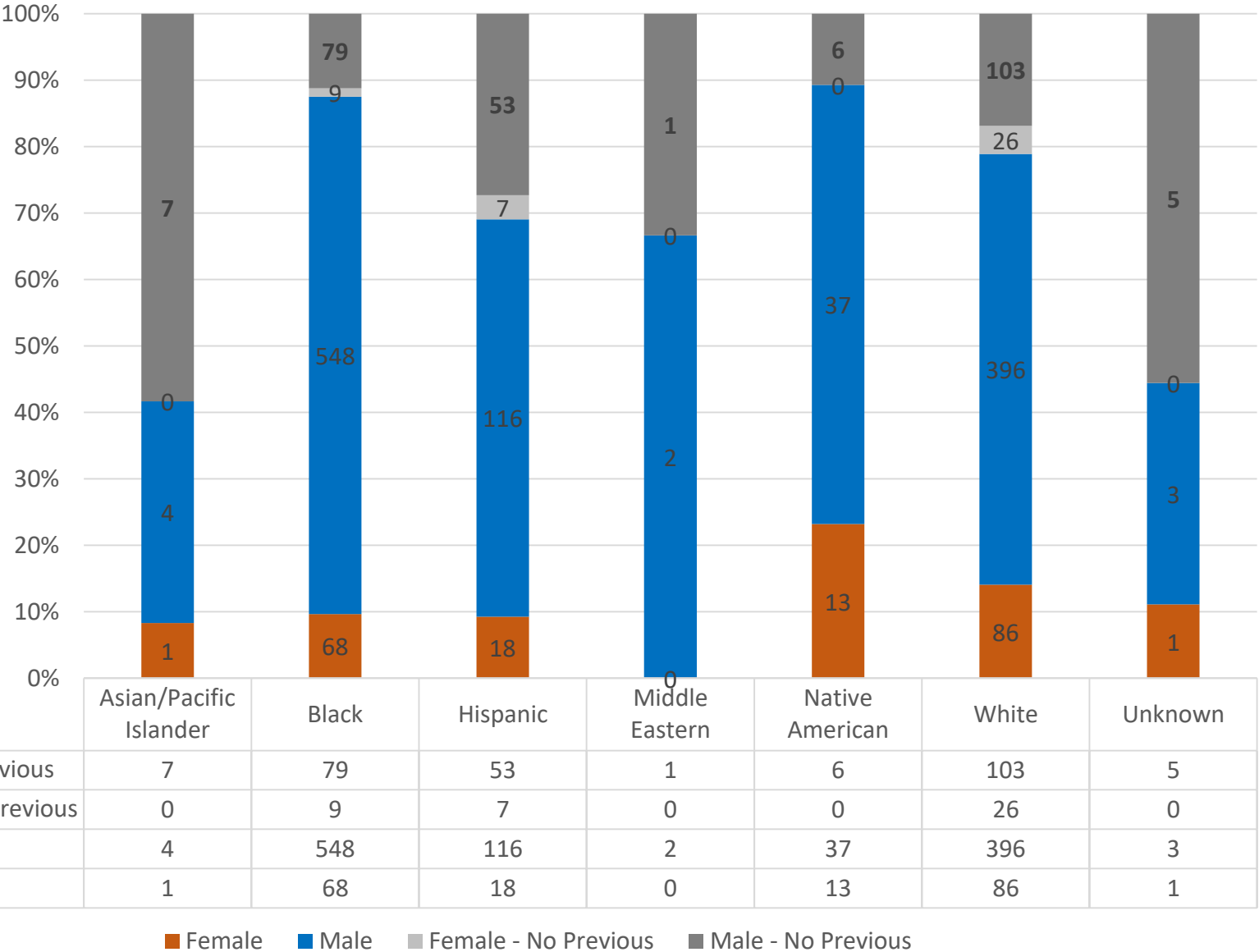

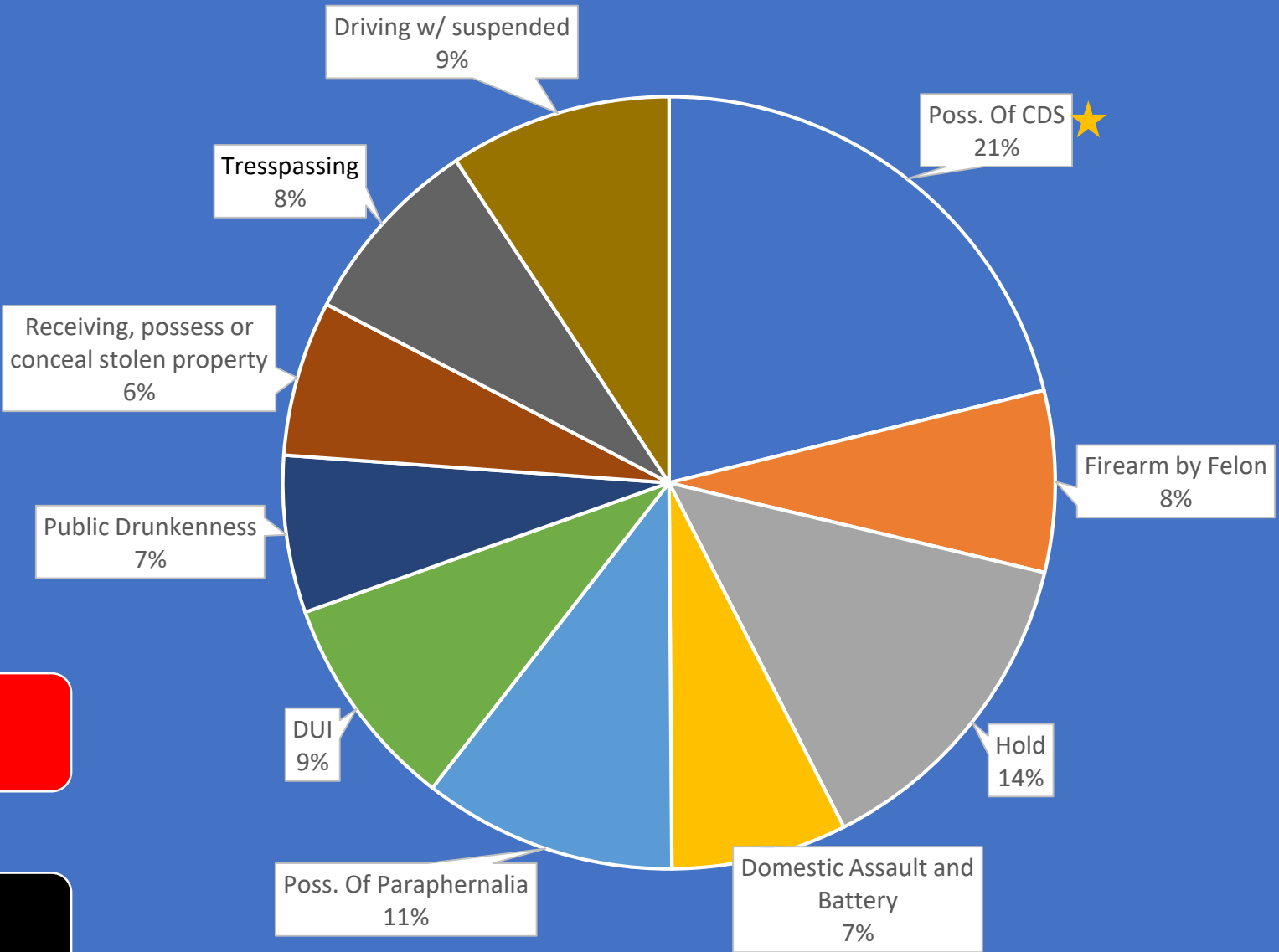
