OKLAHOMA COUNTY PUBLIC BUILDINGS AUTHORITY ACCOUNTING SERVICES AGREEMENT

This agreement is made on this ______ day of June, 2025, by and between the Public Building Authority of Oklahoma County, Oklahoma, designated throughout this agreement as the "PBA", and Steve Landreth, CPA, P.L.L.C., designated throughout this agreement as "Steve Landreth, CPA", and this agreement will confirm the parties understanding of the terms and objectives of this engagement for professional services and the nature and limitations of the compilation services that Steve Landreth, CPA will provide.

1. Steve Landreth, CPA will compile from information provided by the PBA the monthly financial statements as of and for the year ended June 30, 2026 and issue an accountant's report thereon in accordance with Statements on Standards for Accounting and Review Services (SSARSs) issued by the American Institute of Certified Public Accountants (AICPA).

The compiled financial statements are prepared for PBA management purposes. The compiled financial statements will serve as the necessary and proper financial statements for the annual audit that will be conducted by another accounting firm. Steve Landreth, CPA will not audit or review such financial statements. A compilation differs significantly from a review or an audit of financial statements. A compilation does not contemplate performing inquiry, analytical procedures, or other procedures performed in a review. Additionally, a compilation does not contemplate obtaining an understanding of the company's internal control; assessing fraud risk; testing accounting records by obtaining sufficient appropriate audit evidence through inspection, observation, confirmation, or the examination of source documents (for example, cancelled checks or bank images); or other procedures ordinarily performed in an audit. Accordingly, we will not express an opinion or provide any assurance regarding the financial statements being compiled. The monthly reports of the Public Buildings Authority are presently expected to read as follows:

The Trustees are responsible for the accompanying financial statements of Public Building Authority, which comprise the balance sheets of July 31, 2017 and 2016, and the related statements of income and statements of cash flows, and the supplemental information for the one month ended. March 31, 2017 and 2016, We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the financial statements nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by The Trustees, Accordingly, we do not express an opinion, a conclusion, nor provide any assurance on these financial statements.

If management elects to omit substantially all disclosures from the financial statement, Steve Landreth, CPA will include an additional paragraph that will read as follows:

Management has elected to omit substantially all of the disclosures ordinarily included in financial statements prepared in accordance with the income tax basis of accounting. If the omitted disclosures were included in the financial statements, they might influence the user's conclusions about the Company's assets, liabilities, capital, revenues and expenses. Accordingly, these financial statements are not designed for those who are not informed about such matters.

2. The PBA is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America as well as identifying and ensuring that the entity complies with the laws and regulations applicable to its activities. The PBA is responsible for making all financial records and related information

available to us and is responsible for management decisions and functions, and for designating a competent employee to oversee any bookkeeping services, payroll services, tax services, and other services we provide. The PBA is responsible for evaluating the adequacy and results of the services performed and accepting responsibility for such services. The PBA is responsible for establishing and maintaining internal controls, including monitoring ongoing activities, and preventing and detection fraud.

- 3. Steve Landreth CPA is responsible for conducting the engagement in accordance with SSARSs issued by the AICPA. The engagement of Steve Landreth, CPA cannot be relied upon to disclose errors, irregularities, or illegal acts, including frauds or defalcations that may exist. However, Steve Landreth, CPA will inform the appropriate level of management of any material errors that come to their attention and any fraud or illegal acts that come to their attention, unless they are clearly inconsequential. In addition, Steve Landreth, CPA has no responsibility to identify and communicate significant deficiencies or material weaknesses in the PBA's internal control as part of this engagement.
- 4. The fee for the described services will be \$500.00 per month. Steve Landrett, CPA will require the information to prepare the financial statements from the PBA on a monthly basis as soon as possible after the end of the month.
- 5. This fee is based on the current level of business activities. In the event that there is a significant change in the activities, the fee will be subject to change.
- 6. Any additional professional services requested by the PBA will be subject to additional fees not to exceed \$70.00 per hour with total billing of the monthly fee and any additional hourly fees not to exceed \$5000,00 during the term of this agreement.
- 7. This Agreement will be effective on the date executed by all of the parties and will terminate on June 30, 2026. This Agreement shall be renewable for a term of one year beginning on July 1, 2025, to June 30, 2026, and each fiscal year thereafter by the agreement of the parties. Either party may terminate this Agreement at any time upon 30 days written notice.
