WHEREAS, the Oklahoma County Public Buildings Authority (the "Trust") was organized under Title 60, Oklahoma Statutes 2021, Sections 176-180.4, as amended, for the use and benefit of Oklahoma County, Oklahoma (the "County"); and

WHEREAS, the County and the Trust desire to amend the provisions of the Trust Indenture creating the Oklahoma County Public Buildings Authority.

Section 1. First Amendment to the Trust Indenture of the Oklahoma County Public Buildings Authority.
