Amendment #3 to Professional Services Agreement

This Amendment #3 to Professional Services Agreement (the "Amendment") is entered into by and between Bid4Assets, Inc. ("BID4ASSETS") and the Board of County Commissioners of Oklahoma County on behalf of the Oklahoma County Sheriff's Office ("OKLAHOMA COUNTY") as of the date of signature of the last party to sign (the "Effective Date") and amends that certain Professional Services Agreement by and between BID4ASSETS and OKLAHOMA COUNTY, dated as of May 1, 2023 (the "Agreement"). Capitalized terms used herein but not defined herein shall have the meanings ascribed to such terms in the Agreement.

The parties hereto agree to amend the Agreement as set forth below:

- 1. Extension of Agreement. Agreement shall be extended for a period of one (1) year and now terminate on June 30, 2025, unless renewed as described in paragraph 4 of Agreement.
- 2. <u>Electronic Signature: Counterparts.</u> This Amendment may be executed electronically and in any number of counterparts, each of which, when executed, will be deemed to be an original and all of which, when taken together, will be deemed to be but one and the same instrument.
- 3. <u>Effect of Amendment</u>. All of the terms and conditions of the Agreement shall continue in full force and effect except as modified by the terms of this Amendment. In the event of any inconsistency between the terms of this Amendment and the Agreement, the terms of this Amendment shall control and govern.
