2. Based on #1, the following changes were discussed, HOK please confirm each change:
  - 2a. Remove planting/hydroseed area altogether and replace with sod that is already spec'd.
  - 2b. Remove all binder for all crushed granite areas.
  - 2c. No stabilizer required at islands.
  - 2d. Remove hydroseed spec section.
  - 2e. Add back crushed screenings spec section.
