**Subject: 2026 OKLAHOMA COUNTY RETIREMENT BOARD ELECTION**

Pursuant to Title 19 O.S., Sec 952.1, the Board of Trustees of the Oklahoma County Retirement System shall be composed of nine (9) members. Four (4) members are to be current Oklahoma County employees and one (1) member to be an Oklahoma County retiree. An "employee", as used Sections 951 through 962 of this title, shall include the elected or appointed salaried officials and regular full-time salaried employees of a county, and shall also include regular full-time employees of the county board of library trustees, county employees whose salaries are paid in whole or in part from the court fund of such county, employees of county circuit engineering districts, and employees of any public trust created pursuant to law in which the county is the sole beneficiary of the public trust, if approved by the board of County Commissioners.

Jon Wilkerson's employee seat term expires June 30th, 2026. This seat has a term of three (3) years. An election will be held to fill this vacancy. The employee seat is to be filled by an active full-time Oklahoma County employee.

All full-time Oklahoma County retirement plan participants are to vote in the department/location where they are employed.
