Vaquero Resources, LLC ("Vaquero") herein proposes to drill the above referenced horizontal well in Oklahoma County, Oklahoma to a depth sufficient to test the Hunton formation. The proposed drilling and spacing unit (DSU) is further described as follows:

- **EGO FLATS 1202 1-36 1XH: 640 acres, E/2 Sec. 1-11N-2W & E/2 Sec. 36-12N-2W**

Surface Location:	SE/4 of Section 1-11N-2W
Approx. Terminus:	NE/4 of Section 36-12N-2W
Total Vertical Depth:	Approx. 6,380'
Total Measured Depth:	Approx. 17,500'
Dry Hole Costs:	\$2,384,551.00
Completed Well Costs:	\$5,612,416.00

The Oklahoma County records indicate you may own or claim an unleased mineral interest and/or a leasehold interest within this section. Accordingly, Vaquero respectfully requests you choose one of the following:

1. Lease/Assign your unit interest to Vaquero for \$175.00 and a 1/8th royalty (delivering 87.50% net revenue interest). The lease/assignment will be for three (3) years and so long thereafter as oil, gas, or both are produced from the well.
2. Lease/Assign your unit interest to Vaquero for \$125.00 and a 3/16th royalty (delivering 81.25% net revenue interest). The lease/assignment will be for three (3) years and so long thereafter as oil, gas, or both are produced from the well.
3. Participate in the drilling of the well by paying your proportionate share of the aforementioned costs. Enclosed is Vaquero's detailed AFE for your review.

Vaquero is in the process of filing a pooling application with the Oklahoma Corporation Commission, naming as respondents those parties who have not reached an agreement with Vaquero concerning the development of this unit.

Please indicate your preference below and return one (1) executed original of this letter within then (10) days of receipt to Vaquero at the below address or email address. Should you choose to lease/assign your interest, Vaquero will forward to you the necessary documents for signature. Vaquero will require these documents fully executed and returned before dismissing your interest from the pooling application.

Should you elect to participate in drilling of the proposed well, along with an executed original of this letter, please return one (1) executed copy of the AFE along with your well information sheet to Vaquero at the below address or email address. Please include your e-mail address on your well information sheet so that Vaquero may send you digital copies of all reports along with hard copies. In the event you elect to participate in the drilling of the proposed well and wish to be covered by your own well control insurance, you will be required to furnish to Vaquero evidence of such coverage. Any election to participate pursuant to this proposal shall not relieve your obligation to elect in writing to participate per the terms of the pooling order to issue covering this unit.
