

## Amendment 002

Amendment 002 ("Amendment"), dated as of January 1, 2026 (the "Effective Date") is by and between VieMed Healthcare Staffing LLC, a Louisiana limited liability company, with offices located at 625 E. Kaliste Saloom Rd., Lafayette, La 70508, on behalf of itself and its affiliates and subsidiaries ("VHS") and Oklahoma County Criminal Justice Authority (the "Client"). VHS and Client shall hereinafter be referred to as the "parties," with each a "party."

**Background:** Pursuant to the "Staffing Agreement" executed by the Parties on May 1<sup>st</sup>, 2024, Parties may require certain changes to it that are deviations from the terms of the Staffing Agreement. This Client specific Amendment encapsulates such changes.

The following terms in the Staffing Agreement have been changed to reflect the following:

12. Term and Termination.

12.1 This Agreement shall commence as of the Effective Date and shall continue thereafter for a term of two (2) years, unless sooner terminated. Thereafter, this Agreement shall automatically renew for one (1) successive term of one (1) year, until terminated under the terms of this Agreement.
