

02/22/2024 Sole Source Purchase

Sole Source was originally approved on 02/23/2024. It was determined through talking with District 3, that this product would need an additional renewal until July 1 of 2025. Specifications have been drafted and approved and will be on the July 1 Highway Materials, Supplies and Services Bid.

The Purchasing Office proceeded to verify sole source information provided previously was still accurate.

Conducted Research:

- Contacted DuPont and distributor and received documentation.
- Googled multiple keywords to discover any additional sources for this purchase.
- Contacted every asphalt vendor on our current Highway Materials and Services Bid as well as other Asphalt providers found on google
 - Atlas Paving – unable to provide at this time but may be able to provide future quotes
 - TJ Campbell – not able to provide at this time but may be able to provide future quotes
 - Silver Star Construction – doesn't have current capability but can facilitate purchase of necessary equipment if there is a market for it going forward
 - FWCIS/Trinitas – unable to provide at this time
 - Aarow Asphalt – do not operate plant that services this area
 - Ergon Asphalts – Not a process they are capable of performing

Summary of Research Findings:

- To date, Haskell Lemon is still the current provider for the manufacturer of the Kevlar Fiber that will be mixed. DuPont is the manufacturer for this product.
- While there is still room for future competition for this material/service mix, Haskell Lemon is the only provider with this service currently.
- This is a cost effective alternative to more traditional methods. County Engineer has reviewed and is agreeable with renewal.

Conclusion/Recommendation:

It is the recommendation of the Purchasing Office, after research and review, that the materials/service be renewed as sole source until July 1.

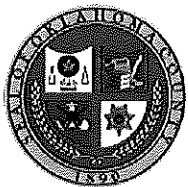

I apologize for the delayed response, yesterday was a little crazy.

Currently we do not have anything at our asphalt plants setup to do this type of additive.

In the recent past, we were in talks with some suppliers of the Ground Tire Rubber additive. They supply the equipment (as a rental) to pneumatically add the GTR to the mixing chamber. I also believe that the fiberglass additive uses a similar process.

So, the short answer is "no" but the long answer is that the manufacturer should have some options.

I would not be able to provide a quote at this time, but we would be willing to speak with the manufacturer and see if we could work up some numbers for you.

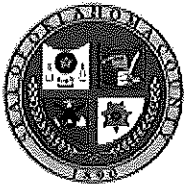

Oklahoma County Highway District 3 submitted a quote for review for an Intersection Reconstruction Project at Waterloo and MacArthur, OK. This requires a specialized mixing of Kevlar fibers into asphalt for repairs.

This product/service is costly and estimates are well over the dollar thresholds. District 3 submitted the required documentation for Sole Source/Sole Brand Acquisition Certification to purchase the necessary service/parts from Haskell Lemon.

The Purchasing Office proceeded to verify sole source as follows:

Conducted Research:

- Sole Source request submitted 2/22/2024.
- Contacted manufacturer and received documentation
- Googled multiple keywords to discover any additional sources for this purchase.
- Contacted every asphalt vendor on our current Highway Materials and Services Bid as well as other Asphalt providers found on Google
 - Atlas Paving – unable to provide at this time but may be able to provide future quotes
 - TJ Campbell – not able to provide at this time but may be able to provide future quotes
 - Silver Star Construction – doesn't have current capability but can facilitate purchase of necessary equipment if there is a market for it going forward
 - FWCIS/Trinitas – unable to provide at this time
 - Aarow Asphalt – do not operate plant that services this area
 - Ergon Asphalts – Not a process they are capable of performing

Summary of Research Findings:

- To date, Haskell Lemon is the current provider for the manufacturer of the Kevlar Fiber that will be mixed. DuPont is the manufacturer for this product.
- While there is room for future competition for this material/service mix, Haskell Lemon is the only provider with this service currently.
- This is a cost effective alternative to more traditional methods. County Engineer has reviewed and is agreeable to moving forward with trying this application.

Conclusion/Recommendation:

It is the recommendation of the Purchasing Office, after research and review, that the materials/service be approved as sole source.

Sole Source Certification is only valid for one year after BOCC approval and should only be used until the product can be added to the next available bid cycle.

Purchasing will work with the requesting department to get specifications for product added to the January 2025 Highway Materials and Services Bid at the latest.

Currently we do not have anything at our asphalt plants setup to do this type of additive.

In the recent past, we were in talks with some suppliers of the Ground Tire Rubber additive. They supply the equipment (as a rental) to pneumatically add the GTR to the mixing chamber. I also believe that the fiberglass additive uses a similar process.
