#### THIRD AMENDMENT TO PAYMENT PROCESSING AGREEMENT

This Third Amendment to Payment Processing (the "Amendment"), is made by and between CSG Forte Payments, Inc., formally known as Forte Payment Systems, Inc. ("FORTE"), and Board of Commissioners of Oklahoma County on behalf of Oklahoma County Treasurer ("AGENCY"). FORTE and AGENCY entered into that certain Payment Processing Agreement effective as of February 21, 2023 (CSG document no. 44257), as amended (the "Agreement"), and now desire to further amend the Agreement in accordance with the terms and conditions set forth in this Amendment. If the terms and conditions set forth in this Amendment shall be in conflict with the Agreement, the terms and conditions of this Amendment shall control. Any terms in initial capital letters or all capital letters used as a defined term but not defined in this Amendment shall have the meaning set forth in the Agreement. Upon execution of this Amendment by the parties, any subsequent reference to the Agreement between the parties shall mean the Agreement as amended by this Amendment. Except as amended by this Amendment, the terms and conditions set forth in the Agreement shall continue in full force and effect according to their terms. Upon execution by each of AGENCY and FORTE, this Amendment shall be deemed to be effective as of July 1, 2025 (the "Amendment Effective Date").

In consideration of the mutual covenants and agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, FORTE and AGENCY agree to the following as of the Amendment Effective Date.

- 1. Section 5.1 or the Agreement shall be deleted in its entirety and replaced as follows:
  - 5.1 **Term.** This Agreement shall have an initial term commencing as of February 21, 2023, and continuing through June 30, 2023 (the "Initial Term") and, pursuant to that First Amendment to Payment Processing Agreement, effective as of July 1, 2023 (CSG document no. 48009), the Agreement renewed through June 30, 2024 (the "First Renewal Term") and to that Second Amendment to Payment Processing Agreement, effective as of July 1, 2024 (CSG document no. 50709), the Agreement renewed through June 30, 2025 (the "Second Renewal Term"), and further, thereafter, shall be further renewed for an additional period of one (1) year commencing on July 1, 2025, and continuing through June 30, 2026 (the "Third Renewal Term"). Thereafter the Agreement may renew by separate written agreement between the parties. AGENCY may terminate this Agreement for convenience at any time after completion of the Initial Term by providing FORTE not less than thirty (30) days' prior written notice.

IN WITNESS WHEREOF, the parties hereto enter into this Amendment as of the Amendment Effective Date.
