Project Understanding & Approach

Existing Conditions

The Design-Build team cored the existing roof September 12, 2025, with the following results.

Core #1 – Typical Condition

(Roofing Area Approximately 26,000 SF)
1/2" Gravel Ballast Second Layer
Coal Tar Pitch Built-Up Roofing Second Layer
1/2" Gravel Ballast First Layer
Coal Tar Pitch Built-Up Roofing First Layer
1/2" Wood-fiber Cover Board
1/8:12 Tapered Polyiso. Insulation
2" Polyiso. Insulation
Structural Concrete Deck

Core #2 – Main Penthouse Roof

(Roofing Area Approximately 3,600 SF)
1/2" Gravel Ballast Second Layer
Coal Tar Pitch Built-Up Roofing Second Layer
1/2" Gravel Ballast First Layer
Coal Tar Pitch Built-Up Roofing First Layer
1/2" Wood-fiber Cover Board
2" Polyiso. Insulation
Steel Decking

The existing roofing terminates at surface-mounted, prefinished metal counterflashing below the existing stone coping. Original through-wall overflow scuppers were covered during the previous reroof. Existing roof drain lines are partially obstructed with tar and gravel. Existing historical limestone copings will be maintained.

The Scope of Work includes replacement of the TPO crossover from the annex building. The remaining portion of built-up roofing at the annex building is excluded. Hazardous material abatement, including asbestos containing material, will be provided by the Owner.

Performance Requirements

The Design-build team shall be responsible for engineered stamped roof plans including surveying, verifying existing conditions, permitting, coordination with other agencies, technical specifications, a standard 20-year roof warranty, workmanship warranty, and all other work associated with to complete design and construction. The Design-Build team shall furnish all labor, equipment, insurance, supervision, and other means of incidental necessary for the turnkey completion of this project. All debris to be properly disposed of according to all applicable local laws and regulations. Time begins on site, no travel or mileage allowed. Awarded contractor shall report to the Oklahoma County Facilities Department/Engineering Department or the assigned Oklahoma County Project Manager upon arrival and check out upon departure. Contractor is expected to abide by Oklahoma County policies related to a drug free and smoke free workplace. Contractors are expected to guarantee all work for a minimum of one year after the date of Final Completion.



Services & System Recommendations

In accordance with the Solicitation, a Cost Proposal is attached.

Our team is well-suited to provide the design and construction services required to meet the Performance Requirements as a turnkey project, all under one Design-Build contract. We have experience with all roofing types and can deliver either single-ply or built-up roofing systems. For its economy, durability, and ease of maintenance in this application, we recommend a 115-mil fully adhered FleeceBack Single-Ply TPO system manufactured by Carlisle with 1/8:12 tapered polyiso rigid insulation and 1/2" HD cover board, providing R-20ci in accordance with the 2009 IECC as adopted by the City of Oklahoma City. The roofing system will terminate at new 24-gauge surface-mounted, prefinished metal counterflashing with drip edge, sealed to the existing stone cladding.

By using FleeceBack TPO in this application, Carlisle's standard 2" hail warranty will be included in the Base Price. The additional cost of the FleeceBack material is offset because it does not require the additional perimeter attachment required for unbacked TPO at the high wind conditions of tall buildings.

The Base Price also includes reopening the existing through-wall overflow scuppers and scoping the roof drain lines. Unit prices are included for roof drain bowl rebuild/ replacement and for cleaning the roof drain lines up to the first elbow.

Areas of the main penthouse's steel roof deck have been damaged from existing leaks. We will provide fastener pull tests in accordance with ANSI/SPRI FX-1 to locate any areas where the deck has rusted and cannot meet the withdrawal resistance requirements of the manufacturer. We will provide a unit price for use where it is necessary to remove and replace the existing decking, and the decking repairs will be designed by the structural engineer.

We found that the existing main penthouse is not insulated, and in order to meet the requirements of the energy code, we must continue the air and insulation barriers up the walls of the penthouse. Identified as an alternate is our recommendation to retrofit the existing metal wall panels with an R-19 insulated metal wall panel system. This approach will not interfere with the existing fire alarm and communications lines running along the interior walls of the penthouse. This alternate also includes sealing all penetrations and ducting any active mechanical outside air intakes to the existing gravity dampers. We will work with the mechanical engineer and facility maintenance to verify which intakes have already been abandoned.

Alternates are also included for replacing the sealant at the stone coping and repairing the limestone cladding of the smaller rooftop penthouse.

The Cost Proposal reflects the limitations of building access, staging, and security at the occupied courthouse in downtown Oklahoma City. Our approach includes exterior access via the eastside parking lot, where 3-4 parking spaces will be needed during the duration of the project.

Project Team Past Performance

The following Table shows the cost estimate accuracy and extent of Change Orders on previous MIDL Architects' Design-Bid-Build projects where Super Roofs was Contractor. For roofing projects, MIDL routinely checks market unit pricing with leading trade contractors which allowed our estimates to remain conservative even during the past few years of extreme volatility. Super Roof's Change Order performance remained below 3% except where we found an opportunity for an overlay deduct at Alcott and where we used tapered insulation to avoid replacement of wood deck that had sagged between the steel structure at Jackson.
