

MEMORANDUM OF UNDERSTANDING
Regarding Reimbursement Agreement

This Memorandum of Understanding (“MOU”) is entered into on this __ day of _____, 2026, by and between:

Board of County Commissioners, located at 320 Robert S Kerr, Oklahoma City, OK 73102 (hereinafter referred to as “BOCC”) on behalf of Oklahoma County Treasurer

and

Public Buildings Authority, located at 321 Robert S Kerr, Oklahoma City, OK 73102 (hereinafter referred to as “PBA”),

Purpose:

The purpose of this MOU is to outline the terms and conditions under which BOCC agrees to reimburse PBA for certain expenses incurred in connection with natural gas services for the District 1 Yard and Treasurer Resale facilities.

1. Scope of Reimbursement

BOCC agrees to reimburse PBA for the following types of expenses:

- District 1 – 70% of Oklahoma Natural Gas (Transportation)
- District 1 – 70% of Symmetry (Athena) Natural Gas Services
- Treasurer – 30% of Oklahoma Natural Gas (Transportation)
- Treasurer – 30% of Symmetry (Athena) Natural Gas Services

All reimbursable expenses must be directly related to natural gas services for the District 1 Yard and Treasurer Resale facilities.

2. Expense Limits and Documentation

- Total reimbursement shall not exceed \$10,000 without prior written approval.
- PBA shall submit original receipts of payment to the BOCC within 30 days.
- BOCC shall reimburse the PBA within 30 days of receipt of acceptable documentation.

3. Duration

This MOU shall remain in effect from July 1, 2026, until June 30, 2027, unless terminated earlier by either party with written notice.

4. Miscellaneous

- Any modifications to this MOU must be made in writing and signed by both parties.
