

RESOLUTION NO. 2022-1654

A RESOLUTION GRANTING PERMISSION TO THE UNITED STATES OF AMERICA THE RIGHT TO CLOSE, INUNDATE, DESTROY, ALTER, OR APPROPRIATE CERTAIN COUNTY HIGHWAY SECTION LINE ROADS.

WHEREAS, the United States of America has requested the Board of County Commissioners the right to close, inundate, destroy, alter or appropriate the following county section line road highways located within Oklahoma County pursuant to 69 O.S. § 649:

All of Douglas Boulevard, a county section line road from South Right of Way line of SE 44th Street to the North Right of Way line of SE 74th Street; and

All of SE 59th Street, a county section line road, from the East Right of Way line of Douglas Boulevard to the West Right of Way line of S. Berryman Road.

WHEREAS, on March 7, 2022, the Oklahoma Department of Transportation issued written approval for the Oklahoma Board of County Commissioners to grant to the United States of America the right to close, inundate, destroy, alter or appropriate the above-described county section line road highways located within Oklahoma County, and

WHEREAS, the purposes stated by the United States of America to close, inundate, destroy, alter or appropriate the above described county section line roads is for construction, development, operations and/or maintenance of Tinker Air Force base, a military project, and

WHEREAS, written notice was mail to 30 property owners within 300 foot radius and a legal notice was published in The Journal Record on April 8, 2022, April 15, 2022, and April 22, 2022, that the Board of County Commissioners would consider the request by the United States of America to close, inundate, destroy, alter or appropriate the above referenced county section line road highways located within Oklahoma County at their May 16, 2022 regularly scheduled meeting located at 320 Robert S. Kerr, Suite 204, Oklahoma County, Oklahoma, 73102 .

NOW THEREFORE BE IT RESOLVED, the Board of County Commissioners of Oklahoma County does hereby grant to the United States of America/Tinker Air Force Base the right to close, inundate, destroy, alter or appropriate the following county section line road highways located within Oklahoma County:

All of Douglas Boulevard, a county section line road from South Right of Way line of SE 44th Street to the North Right of Way line of SE 74th Street; and

All of SE 59th Street, a county section line road, from the East Right of Way line of Douglas Boulevard to the West Right of Way line of S. Berryman Road.

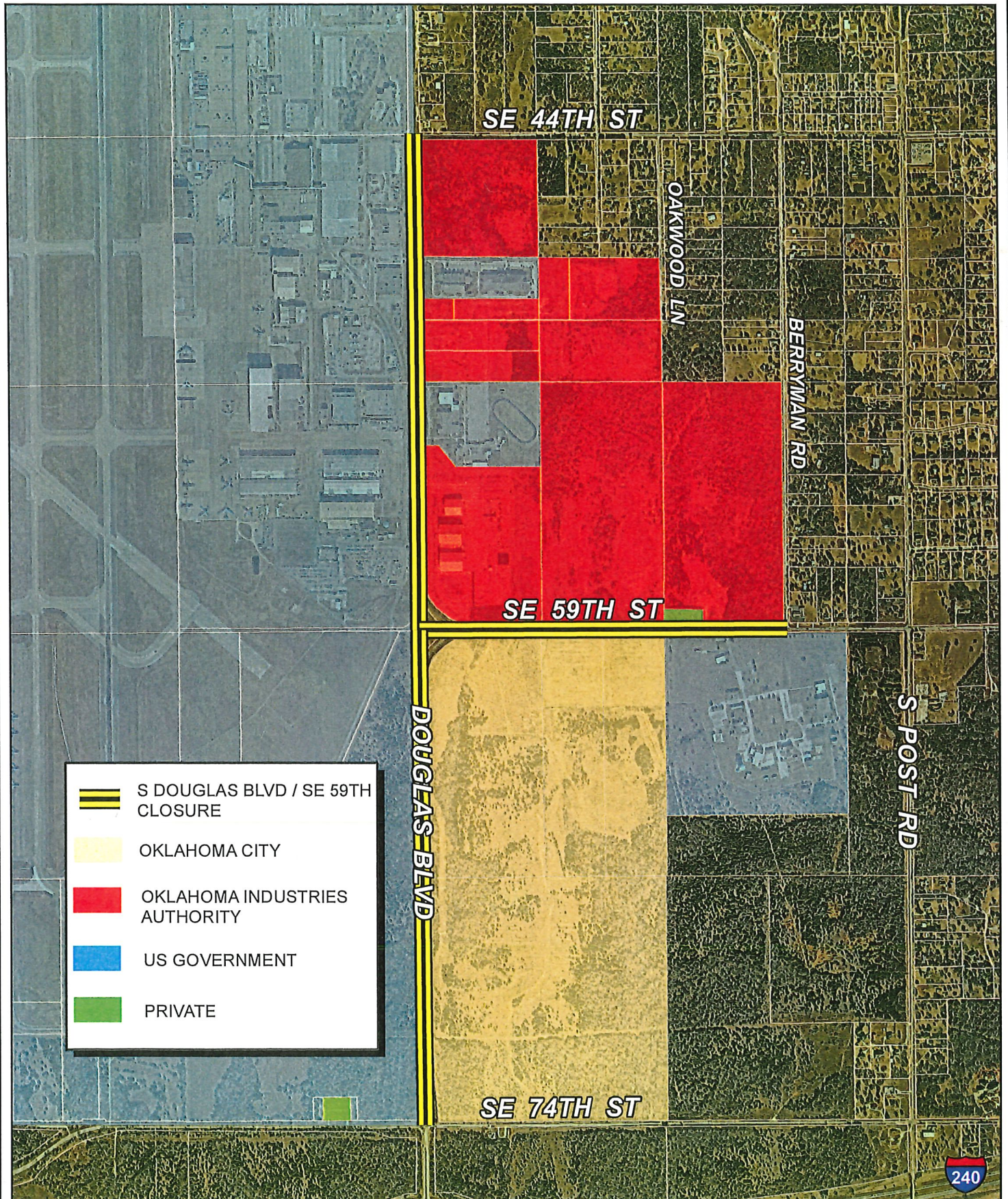
