Option #1: Daily Inmate Per Diem Rate Calculation

MGT shall perform a cost analysis to include both direct and indirect costs to determine the daily inmate per diem rate from intake to release based on the overall inmate population at the Oklahoma County Detention Center. This analysis will be based on an inflationary factor from the prior years approved per diem rate, with adjustments for known changes to FY 2022 actual costs and inmate population. MGT shall prepare a report summarizing the new proposed daily inmate per diem rate for presentation to the Oklahoma County District Judge and provide testimony in support of the cost analysis if needed.

Cost for Option 1 - \$5,100 plus travel costs if required.

Option #2: Daily Inmate Per Diem Rate Calculation

MGT shall perform a cost analysis to include both direct and indirect costs to determine

the daily inmate per diem rate from intake to release based on the overall inmate population at the Oklahoma County Detention Center. This analysis will be based on actual costs and inmate population statistics from FY 202. MGT shall also prepare a report summarizing the new proposed daily inmate per diem rate for presentation to the Oklahoma County District Judge and provide testimony in support of the cost analysis if needed.

Costs for Option 2 - \$8,100 plus travel costs if required;
