A part of the North Half ( $\mathrm{N} / 2$ ) of the South Half ( $\mathrm{S} / 2$ ) of the Northwest Quarter (NW /4) of Section Twenty-four (24), Township Eleven (11) North, Range Two (2) West of the Indian Meridian, Oklahoma County, Oklahoma, being more particularly described as follows: Commencing at the Northwest Corner of the NW/4 of Section 24; Thence due South along the West line of said NW/4 a distance of 1761.77 feet to the point or place of beginning; Thence continuing due South along said West line of Section 24 a distance of 220.00 feet to the Southwest corner of said N/2 of the S/2 of the NW/4; Thence South $89^{\circ} 53^{\prime} 26$ " East a distance of 400.00 feet; Thence due North a distance of 220.00 feet; Thence North $89^{\circ} 53^{\prime} 26^{\prime \prime}$ West a distance of 400.00 feet to the point of beginning;

The West Half (W $1 / 2$ ) of the Southeast Quarter (SE1/4) of Section Twenty-four (24), Township Eleven (11) North, Range Two (2) West of the Indian Meridian, in Oklahoma County, Oklahoma, LESS Two (2) Acres in the Southwest Corner used for Cemetery Purposes: Beginning at the Southwest corner of said Southeast Quarter (SE1/4); Thence North along the West line of said Southeast Quarter a distance of 210 feet; Thence East and parallel to the South line of said Southeast Quarter a distance of 420 feet; Thence South and parallel to the West line of said Southeast Quarter a distance of 210
feet; thence West along the South line of said Southeast Quarter a distance of 420 feet to the point of place of beginning
